RACE 1 – LADBROKES SUPPORT TASMANIAN RACING PACE – 2090 METRES

NAPATTACK SAM – Was held up for clear running until the latter stages of the home straight - Finished strongly once clear.

HUGHIE PLAYBOY – Led then surrendered the lead near the 1600 metres.

ROCKNROLL NITRO – Worked forward from outside the leader to take over the lead near the 1600 metres. Withstood a challenge for the lead between the 1600 and 1400 metres.

FURY DAN – Commenced a three-wide run from one out one back near the 1700 metres to work forward to the position outside the leader near the 1500 metres at which stage it issued a short unsuccessful challenge for the lead.

RACE 2 – PRYDES EASIFEED PACE – 2090 METRES

DREAMS ARE BETTOR – Raced in a three back peg line position then gave ground over the concluding stages.

CAROLS JUDGE – Led then surrendered the lead after 350 metres.

LILY ROCKS – Broke in the score up. Raced erratically in the score up. Having considered the filly's recent starting record, Stewards ordered that LILY ROCKS be placed out of the draw in mobile barrier races. Raced in a one out one back position until being left leading the one wide line after 350 metres. Obtained a one out one back trail approaching the 1400 metres.

CINOCAL JAMANE – Worked forward from outside the leader to take over the lead after 350 metres.

NAVUA PIXIE – Commenced three-wide run from one out two back near the 1600 metres to take over the position leading the one wide line approaching the 1400 metres.

RACE 3 – CASCADE DRAUGHT PACE – 2090 METRES

ARTHUR ELLIOTT – Held up for clear running until the latter stages of the home straight - Finished strongly once clear.

STEPPING STONES – Raced three-wide for the first 600 metres, eventually being restrained to the rear of the field. Three wide two back from the 1000 metres.

BRIGHTON PRINCE - Raced three-wide for the 400 metres whilst being restrained to the rear of the field.

DEBT TILL WE PART – Three wide one back from the 1000 metres.

SOMEHOWSOMEWAY – Out of position when the start was effected. When questioned driver, Dylan Ford, explained to the Stewards that he was drawn behind the one horse, ARTHUR ELLIOTT and approximately 150 metres before the start he noticed ARTHUR ELLIOTT put in a 'bop' and for that reason he elected to show extra care. Stewards verified Mr Ford's remarks and no further action was taken. Commenced a three-wide run from midfield near the 1000 metres.

LOYOLA TRIOS – Utilised the sprint lane in the run to the finish.

RACE 4 – TASMANIAN TROTTING CLUB 2YO SWEEPSTAKES COLTS & GELDING FINAL 2021 – 1609 METRES

BIG BOY MAL – Led then surrendered the lead approaching the 1300 metres. Broke free of interference in the home straight on the final occasion - Placed on its last chance to raced truly.

 $MICKEY\ OH-Worked$ forward from outside the leader to take over the lead approaching the 1300 metres. Held back for post-race blood samples to be taken.

MAGIC JOE – Raced three-wide for the first 350 metres whilst being retrained to the rear of the field. Severely checked and broke racing into the home straight on the final occasion.

MONEYS NO ISSUE – Slightly out of position when the start was effected - no action taken due to this being a 2 year old having only its second start.

MUCHO MOVER – Was held up for clear running around the final turn, then broke free of interference entering the home straight on the final occasion. Stood from racing for 14 days and the completion of two satisfactory trials.

MAEBEE – Raced in a one out back position until being left leading the one wide line approaching the 1300 metre point. Second placed, swabbed. Held back for post-race blood samples to be taken.

RACE 5 – TASMANIAN EQUINE VETERINARY SERVICE PACE – 2090 METRES

BELIEVE IN FOREVER – Utilised the sprint lane in the run to the finish.

KARDESLER NZ – Led the one wide line until obtaining a one out one back trail after 400 metres. Hung out in the back straight on the final occasion when racing in tight quarters, resulting in RACKETEERS BOY NZ to its outside being checked and breaking as a result. Stewards placed KARDESLER on its last chance to race truly.

MURRY – Worked forward three-wide to take over the position leading the one wide line after 400 metres. Obtained a one out one back trail near the 1250 metres.

RANIERI NZ – Raced three-wide for the first 450 metres, eventually being restrained to one out three back position. Commenced a three-wide run from midfield approaching the 1000 metres.

LOCKAWAY KACIE – Led, however was unable to hold the lead losing that position approaching the 1400 metres. Shifted out to lead the one line near 1250 metres.

MONTANA LAD NZ – Commenced a three-wide run from towards the rear of the field near the 1600 metres to work forward to the lead approaching the 1400 metres.

RACKETEERS BOY NZ - Three wide one back from the 1000 metres. Checked and broke near the 500 metres.

SOMEDAN - Three wide two back from the 1000 metres.

RACE 6 – TASMANIAN TROTTING CLUB 2YO SWEEPSTAKES FILLIES FINAL 2021 – 1609 METRES

The all clear for this race was delayed when at the all clear point Rohan Hillier, driver of second past the post MISS PAPENHUYZEN, requested to view the official race videos to ascertain whether he had grounds for a protest. After viewing the videos, Mr Hillier lodged a protest against MAYS PLACE, being declared the winner on the grounds of interference in the home straight on the final occasion. At the resulting protest hearing Stewards took evidence from Rohan Hiller and Gareth Rattray, driver of MAYS PLACE, and Kent Rattray, trainer of MAYS PLACE and viewed the official race videos. Having considered the evidence, Stewards dismissed the protest and the all clear was given on the Judge's numbers. In dismissing the protest, Stewards had considered that, although MAYS PLACE had shifted up the track in the home straight on the final occasion, MISS PAPENHUYZEN to its outside was also shifting up the track of her own accord. Further, at a point approximately 80 metres from the finish line, the sulky wheels of the runners touched briefly, however Stewards felt neither runner lost any momentum and that Mr Hillier was able to continue to drive his filly to the line. Stewards were not comfortably satisfied that any incident had occurred that warranted changing the placings and the protest was dismissed and the all clear given. A subsequent enquiry Garth Rattray, driver MAYS PLACE was fined \$200, Mr Rattray having pleaded guilty to a charge under the provisions of AHHR168(1)(a), in that on the home straight in this occasion he allowed or failed to make sufficient effort to prevent MAYS PLACE from shifting up the track in the run to the finish.

OUR BRIGHT LIGHT – Led then surrendered the lead near the 1250 metres.

MISS PAPENHUYZEN – Worked forward three-wide to take over the position leading the one wide line approaching the 1000 metres. Shifted out in the home straight on the final occasion. A protest lodged, second versus first, was dismissed

GUENEVERES MADONNA – Led the one wide line until obtaining a one out one back trail near 1000 metres. Broke free of interference near the 800 metres - Placed on its last chance to race truly.

MAYS PLACE – Worked forward three-wide to take over the lead near the 1250 metres. Shifted out under pressure in the run to the finish. Withstood protest second versus first. Driver Gareth Rattray was fined \$200, Mr Rattray having pleaded guilty to a charge under the provisions of AHHR168(1)(a) – careless driving, in that in the home straight on the final occasion, he allowed or failed to make sufficient effort to prevent MAYS PLACE from shifting up the track in the home straight on the final occasion.

RACE 7 – NUTRIEN SPRINTLANE PACE – 2090 METRES

MY CELEBRITY – Led the one wide line until obtaining a one out one back trail until after 450 metres. Tired over the concluding stages to be beaten in excess of 70 metres. Having considered the gelding's recent race record, Stewards ordered that MY CELEBRITY must complete a satisfactory requalifying trial before being eligible to race again.

TARLETON RILEY – Was well out of position when the start was effected, despite its driver's best efforts. Placed on its last chance in the draw in mobile barrier races.

CHRISTIAN JAZZ NZ – Locked sulky wheels with another runner and checked in the latter stages of the back straight on the final occasion. An inquiry will be conducted into the circumstances.

SEA HAWKE – Worked forward three-wide to take over the position leading the one wide line after 450 metres. Obtained a one out one back trail near the 1400 metres. Gave ground over the concluding stages.

PERFECT MACH – Locked sulky wheels with another runner in the latter stages of the back straight on the final occasion. An enquiry into the circumstances was adjourned as Rohan Hiller driver of CHRISTIAN JAZZ NZ was required for the enquiry, however Mr Hiller had left the course.

IDEN FOREST – Hung out in the score up and was out of position when the start was effected - Placed on its last chance in the draw in mobile barrier races. Hung out on several occasions during the race - A warning was issued. Commenced a three-wide run from towards the rear of the field near 1800 metres to take over the position leading the one wide line near the 1400 metres.

KARALTA DAZZLER – Checked behind two runners which locked wheels in the latter stages of the back straight on the final occasion.

COOLHAND EASTON NZ – Raced three-wide for the first 400 metres whilst being restrained to the rear of the field. Placed back in the draw in mobile barrier races.

RACE 8 – LADBROKES PARK PACE – 2090 METRES

This race started approximately 2 minutes behind the scheduled starting time due to ROWLEY NZ requiring major gear adjustments.

ROCKNOVERTIME – Led and withstood an early challenge for the lead.

JOBELLS IMAGE – Held up and checked behind a tiring runner in the back straight on the final occasion.

JUNIPER - Late on the track due to driver G Rattray being delayed in the Stewards Room.

ROWLEY NZ – Was retired from the race by its driver near the 600 metres. A post-race veterinary examination revealed the gelding to have bled form both nostrils. This being the gelding's second bleeding episode, acting under the provisions of AHHR101(3)(b), Stewards ordered ROWLEY NZ be stood down from racing for life.

BIG GEM MONTANA – Mounted a short unsuccessful challenge for the lead and obliged to lead the one wide line thereafter. Pulled hard throughout the middle stages of the race. Tired over the concluding stages to be beaten in excess of 179 metres. Stewards ordered a post-race veterinary examination of the gelding which revealed the gelding to have a slow recovery rate. Stewards ordered that BIG GEM MONTANA be stood down from racing until its completion of a satisfactory requalifying trial.

ROQUEFORT CHEESE – Broke shortly after the start was effected - Placed out of the draw in mobile barrier races. Three-wide to back from the 1000 metres.

ROCK ON PLAYBOY – Utilised the sprint lane on the run to the finish.

THE FLOYD – Broke in the score up and out of position when the start was effected taking no competitive part in the race. Placed out of the draw in mobile barrier races.

GUIDO DA SIENA NZ - Commenced a three-wide run from towards the rear of the field near the 1200 metres.

DENWEN DANCER - Three wide one back from 1200 metres.

BOSTON BUSKER - Checked behind a tiring runner in the back straight on the final occasion.

RACE 9 - PRYDES RACE CUBE PACE - 2090 METRES

STAR WATCHING – Led then surrendered the lead after 450 metres.

SPORTS ILLUSTRATOR – Led the one wide line until obtaining a one out one back trail approaching the 1000 metre point. Checked behind a tiring runner in the back straight on the final occasion.

PAWNBROKERS LAD – Worked forward from outside the leader to take over the lead after 450 metres. Surrendered the lead shortly afterwards.

DEAL BREAKER - Worked forward three-wide to take over the lead after 500 metres.

KEEP PLAYING - Commenced a three-wide run from midfield approaching he 1000 metre point.

MACHAVELLI – Raced four-wide for the first 400 metres, prior to restraining to a one out one back position. Checked behind a tiring runner in the back straight on the final occasion.

THE DEAL – Utilised the sprint lane in the run to the finish.

IDEAL INVESTMENT – Commenced a three-wide run from towards the rear of the field at the 1300 metres. Worked forward to take over the position leading the one wide line approaching the 1000 metres. Commenced to tire from the 500 metres ultimately being beaten in excess of 173 metres. Stewards ordered a post-race veterinary examination of the gelding which revealed it to have suffered an atrial fibrillation. Acting under the provisions of AHHR101C(2)(a), Stewards ordered IDEAL INVESTMENT stood down from racing for 14 days and until the completion of a satisfactory requalifying trial. As well, a veterinary certificate including an ECG report must be submitted prior to the gelding trialling.

GOT THE GOODS – Three wide one back from the 1000 metres.

MACH CHARM - Three wide two back from the 1000 metres.

APHRODISIAC – Broke in the score up and was out of position when the start was effected - Will continue to be placed out of the draw in mobile barrier races.

RACE 10 - TASMANIAN HORSE TRANSPORT PACE - 2090 METRES

This race started approximately 3 minutes behind the scheduled starting, due to a sulky change being required on one of the runners.

HEZ RAZOR SHARP – Led then surrendered the lead after 400 metres. Utilised the sprint lane in the run to the finish.

TALLY OPERATOR – Raced three-wide for the first 400 metres whilst working forward to the lead. Surrendered the lead near 1600 metres.

STAVROS THE TERROR NZ – Raced three-wide with a trail for the first 400 metres then worked forward three wide to take over the lead near the 1500 metres.

ONLY IN ROME NZ - Three wide one back from the 1000 metres. Placed back in the draw in mobile barrier races.

RISING HIGH – Pulled hard throughout the middle stages of the race then gave ground noticeably over the concluding stages. Driver Ricky Duggan reported that the gelding had choked down. This being the case, Stewards ordered that RISING HIGH must complete a satisfactory requalifying trial before being eligible to race again. Placed back in the draw in mobile barrier races.

METRO MAN – Commenced a three-wide run from towards the rear of the field near the 1000 metres. Tired over the concluding stages to be beaten 70 metres. Placed on its last chance race competitively.
