RACE 1 – TRAINER ENCOURAGEMENT PACE – 2200 METRES

HES APPLES paced roughly after the start.

SPORTY BEN was caught wide early before restraining to the rear of the field.

IDEAL KARALTA worked forward three wide in the early stages to take the lead.

Driver P Williams (DEBT TILL WE PART) was fined the sum of \$200 under AHRR156(2)(a). Particulars were that he used his whip with more than a wrist only flicking motion.

Driver L Older (CASTOR TROY) was fined the sum of \$200 under AHRR156(2)(a). Particulars were that he used his whip with more than a wrist only flicking motion.

Driver A Collins (MURRY) was fined the sum of \$200 under AHRR156(2)(a). Particulars were that when driving his horse out in the home straight he used his rein with more than a wrist only flicking motion.

Driver B Jaffray (SEVENTHREEOHSEVEN) was suspended for 2 race dates after pleading guilty to a charge under AHRR163(1)(a)(iii). Particulars were that just after turning for home the final time he shifted his horse wider on the track when not sufficiently clear of the front legs of HES APPLES (D Ford) causing that horse to be checked and ultimately break.

RACE 2 – SAMPAN STAKES – 2200 METRES

MISS PAPENHUYZEN worked forward three wide early to race outside the leader

GOING GREAT GUNS contacted a marker peg when racing in restricted room.

THEUGLYSISTER broke free of interference and has been placed on its last chance to race truly.

SOLO SYNC broke free of interference and has been stood down until the completion of a satisfactory trial.

RACE 3 – BETTY LEE PACE – 2200 METRES

DRAGON BLOOD broke shortly after the start and has been placed out of the draw in future mobile events.

GUENEVERES MADONNA was severely checked after the start.

MISS BARTY was checked and broke after the start and then took no competitive part in the event.

STAR ROCKER was inconvenienced shortly after the start.

PRIDDY SUBLIME was severely checked after the start.

CARDINAL SIN NZ was checked and broke shortly after the start.

STAR RULER NZ was inconvenienced after the start then tired to be beaten in excess of 124 metres. The gelding has been stood down until the completion of a satisfactory trial.

DRAGON BLOOD broke free of interference and has been stood down until the completion of a satisfactory trial.

LITTLEBITOFMAGIC failed to circle unassisted and was out of position at the start. The gelding will continue to be right out of the draw in future mobile events.

LITTLEBITOFMAGIC tired to be beaten in excess of 124 metres and will be stood down until the completion of a satisfactory trial.

RACE 4 – GOING SOUTH PACE – 1680 METRES

CASTLE RETREAT broke in the score up and was out of position at the start. The gelding will be placed out of the draw in future mobile events.

THE DEMOCRAT broke shortly after the start and will be placed out of the draw in future mobile events.

CASTLE RETREAT broke approaching the home turn and eventually fell. A veterinary examination revealed abrasions to the hind legs and a cut above the eye. The gelding has been stood down until the receipt of a veterinary clearance and the completion of a satisfactory trial.

Driver C Crossland was examined by the medical personnel and passed fit to complete his engagements.

Driver G Rattray (STORMY SANZ) was fined the sum of \$100 after pleading guilty to a charge under AHRR162(1)(www)(c). Particulars were that he allowed his horse to shift ground in the home straight allowing ROCKS ROY to gain an inside run.

RACE 5 - DOUG MARTIN DANBURY PARK CUP - 2698 METRES

This race was called off after 400 metres when MIGHTY FLYING ART NZ (C Crossland) galloped and locked wheels with CALL ME HECTOR (M Cooper) dislodging both drivers. The driverless horses continued on in the race before being caught by the Clerks of the Course.

CALL ME HECTOR underwent a veterinary examination after being caught which revealed a compound fracture of its off-side fore cannon bone. The gelding was humanely euthanised.

MIGHTY FLYING ART NZ broke after the start, locked wheel and dislodged its driver; underwent a veterinary examination after being recaptured which revealed abrasions to the hind legs and was declared a late scratching.

After examination by the on-track paramedics with, Cody Crossland was cleared to fulfill his engagements and Matthew Cooper was transported to hospital for further assessment.

Due to the delay in transporting Mr Cooper to hospital the re-run of this race was delayed for 1.5 hours, and all remaining races were rescheduled.

Prior to the re-run all horses underwent pre-race veterinary inspections and were passed suitable to race.

HICKSTEAD NZ galloped away and will continue to be out of the standing start draw.

RYLEY MAJOR galloped away and has been placed on its last chance in the standing start draw.

SUNNY SANZ was held up early before gaining clear running in the home straight.

LIP READER was held up early before gaining clear running in the home straight.

FRANCO HAMPTON NZ raced outside the leader and pulled hard before tiring to be beaten in excess of 99 metres. The gelding underwent a post-race veterinary examination which failed to reveal any significant findings and was placed on its last chance to race competitively.

Driver M Yole, (CULLENBURN NZ) was cautioned regarding his whip action and was advised to modify his action to prevent any breaches of the whip rule.

RACE 6 – MERRY CHRISTMAS STAKES – 2200 METRES

SCOTLYNN BEACH NZ jibbed in the score up and was out of position at the start. The gelding has been placed out of the draw in future mobile events.

LYNRYD SKYNRYD NZ was out of position at the start and will continue to be excluded from the mobile draw.

OUR BALOU underwent a post-race veterinary examination after tiring to be beaten in excess of 75 metres. No abnormalities were detected and the gelding has been stood down for a period of 14 days and until the completion of 2 satisfactory trials.

MONTANA FLASH underwent a post-race veterinary examination after tiring to be beaten in excess of 51 metres. No abnormalities were detected and the gelding has been stood down for a period of 14 days and until the completion of 2 satisfactory trials.

MAJOR GENERALJUJON underwent a post-race veterinary examination after tiring to be beaten in excess of 90 metres. No abnormalities were detected and the gelding has been stood down for a period of 14 days and until the completion of 2 satisfactory trials.

WHERE YA BIN NZ was out of position at the start. Driver K Pratten was reprimanded under AHRR162(1)(j) for failing to maintain his position until the start

RACE 7 – SHIRLEY MARTIN MOTHER OF PEARL – 2200 METRES

MACH BRILLIANCE broke in the score up however was in position at the start. No action was taken.

SO ART I NZ galloped after the start and has been placed out of the draw in future mobile events.

FORGOT THE WALLET hung in during the score up and was out of position at the start. The mare has been placed on its last chance in the mobile draw.

STEPPING STONES was out of position at the start and has been placed on its last chance in the mobile draw.

SO ART I NZ tailed the field and was retired from the event. The mare has been stood down until the completion of a satisfactory trial.

MACH BRILLIANCE underwent a post-race veterinary examination after tiring to be beaten in excess of 126 metres. No abnormalities were detected and the mare has been stood down until the completion of a satisfactory trial.

RACE 8 – LU RAIDER PACE – 1680 METRES

URUS NZ was caught wide early before working forward to race outside the leader.

IM ROCK SOLID was caught wide early before being restrained to the rear of the field.

DEADLY ASSASSIN was held up and unable to be fully tested.

RACE 9 – LOGAN DERBY STAKES – 2200 METRES

PROSECUTION WITNESS NZ was out of position at the start and has been placed on its last chance in the mobile draw.

SON OF RAYSON underwent a post-race veterinary examination after tiring to be beaten in excess of 88 metres. No abnormalities were detected. The gelding has been placed on its last chance to race competitively.

MAJOR DAVVIN underwent a post-race veterinary examination after being beaten in excess of 52 metres which revealed no abnormalities.
