## Comments / Explanations:

Trainer S Brunton was fined the sum of \$100 for the late rider declarations under the provisions of LR13.3 for Race 3 BRINKTOP LAD and Race 8 FINXY.

Trainer S Brunton was reprimanded under the provisions of AR16(b)(iii) for negligence in engaging a rider who was unavailable in Race 7.

## RACE 1 – ALEXANDRA PLATE 2-Y-O (1100 Metres)

**THOROS OF MYR –** Shifted in abruptly approaching the winning post.

**GLEBELY –** Slow to muster early speed.

**BOBBLE –** Shifted in on jumping and was slow to muster early speed.

# RACE 2 - MONOTONE MAIDEN 3-Y-O & UP - (1200 METRES)

The start of this race was delayed when the electronic start failed on the barriers and the start was reverted to a manual start.

**CONUMDRUM –** Over-raced in the early and middle stages, raced erratically approaching the 700 metres, shifting out forcing CREEK LODGE wider.

**CREEK LODGE –** Bumped with DING DING shortly after the start, raced wide throughout.

**GEE GEES FIFTHTEST** – Stood flat footed and was slow to muster early speed. A post-race veterinary examination failed to reveal any abnormalities.

**HIGH PLAIN DRIFTA -** Slow to begin and shifted in on jumping

**SWINGAPINGA** – A post-race veterinary examination failed to reveal any abnormalities.

I'M KEEFE – Laid in approaching the 300 metres and brushed with ZULU ANGEL. Bumped with MILLA'S READY prior to the winning post unbalancing both riders. Rider L Riordan was reprimanded under the provisions of AR131(a) Careless riding for allowing his mount to shift in when not fully clear.

**MUSCLE UP –** Jumped inwards at the start bumping with DING DING, raced wide throughout.

**ZULU ANGEL** – Shifted in when placed under pressure over the concluding stages.

**WEALLSTUCKATHOME** – Disappointed for a clear run inside the 100 metres.

**DING DING –** Bumped with MUSCLE UP at the start, then shifted in bumping with CREEK LODGE shortly after, raced four wide in the early stages.

**KING ON QUEENS –** Slow to begin, held up from about the 200 metres to the winning post.

MILLA'S READY - Raced wide throughout.

## RACE 3 – LADBROKE IT! BM62 HCP – (1200 METRES)

The start was delayed 3 minutes due to ZIAVERA arriving to barriers and the bridle being replaced.

**BRINKTOP LAD** – Raced three wide to the 600 metres. Rider E Byrne Burke reported the gelding was galloped on during the race. A post-race veterinary examination revealed the gelding had sustained lacerations to near hind.

**MR FREEZE –** Commenced awkwardly and was slow to begin as a result.

**SHAMPZ AGAIN –** Raced wide throughout.

**ZIAVERA** – Slow to begin and was slightly inconvenienced by MAGIC TYPHOON which shifted out.

**NEV'S BOY –** Rider I Toker pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) in that he used his whip on nine occasions prior to the 100 metres. In assessing penalty stewards considered his recent record in relation to the rule and his guilty plea. He was subsequently fined the sum of \$500.

**SWING KING** – Bounded out on jumping, raced three wide throughout.

**ZADE'S STORIES –** Raced wide throughout.

**MAGIC TYPHOON –** Shifted out on jumping slightly inconveniencing ZIAVERA.

# RACE 4 - TASMANIAN BLOODSTOCK BM64 HCP F & M - (1400 METRES)

**BLUSHED** – Brushed with SILVER PERSUASION approaching the 250 metres.

**SILVER PERSUASION –** Brushed with BLUSHED approaching the 250 metres.

**TWEE** – commenced awkwardly.

**NEED A FLUTTER –** Jumped awkwardly and was so slow to begin as a result.

**ZEVA ROYALE** – Underwent a pre-race veterinary examination after the Trainer reported the mare sustained superficial abrasions to the near side rump travelling to the course. The mare was passed fit to compete. Raced wide throughout, over raced in the early and middle stages.

### RACE 5 - KEVIN SHARKIE TASMANIAN STAKES - (1600 METRES)

**THE INEVITABLE –** Shifted in when the whip was used entering the home straight. Lost near hind tip in the run.

### RACE 6 – ELWICK FUNCTIONS & EVENTS BM72 HCP – (1400 METRES)

**SHARMA'S LAST –** Restrained from a wide barrier to take up a position closer to the rails.

**CORNELIAN BAY –** Shifted in passing the 1200 metres when not fully clear of GEEGEES JEMSTONE which had to be steadied.

**GEEGEES GEMSTONE –** Over-raced shortly after the start, steadied passing the 1200 metres when CORNELIAN BAY shifted in, laid in for a major part of the home straight.

#### **RACE 7 GRAHAM FAMILY FUNERALS BRIGHTON CUP – (2100 METRES)**

**GLASS WARRIOR –** Raced wide from the 1000 metres.

**SO ASTOUNDING –** A post-race veterinary examination failed to reveal any abnormalities.

**TRAVELLING GIGOLO –** Over-raced in the early stages.

**KING ISLAND –** Brushed after jumping with TRAVELLING GIGOLO and BELL RINGER BOY who both shifted ground.

**STEEL SKIES** – Was declared a late scratching at 5:56PM on veterinary advice after becoming fractious in the barriers and rearing. Trainer J Flannery was advised that the gelding will be required to trial satisfactorily prior to racing again. On the announcement of correct weight stewards ordered that all monies invested on STEEL SKIES be refunded, with the following deductions to apply to successful wagers placed prior to 5.56pm.

#### **Deductions**

```
(1<sup>st</sup>) Glass Warrior – 5 cents a win & 7 cents a place
(2<sup>nd</sup>) Travelling Gigolo – 4 cents a place
(3<sup>rd</sup>) Bell Ringer Boy – 6 cents a place
```

All monies bet after the withdrawal to be paid at face value of the ticket.

**ALWAYS A WINNER –** Stewards granted permission for rider I Toker to ride 1kg over the minimum allotted weight. Over-raced in the early and middle stages, held up in the home straight.

**NOT A BRASS RAZOO (NZ) –** Stewards spoke to Rider C Newitt in relation to the mares disappointing performance. Rider C Newitt stated the mare was not suited by the rise in class in today's race. A post-race veterinary examination failed to reveal any abnormalities.

THE EXECUTIVE - Raced three wide to the 1400 metres.

**SUNSET GUN –** Over-raced in the early stages, carried wider rounding the home turn by TRAVELLING GIGOLO which shifted out to improve.

THE DECIDER - Raced three wide to the 1200 metres

## RACE 8 – WINNING EDGE PRESENTATIONS CLASS 1 HCP – (1400 METRES)

Prior to the declaration of correct weight, Stewards considered a protest lodged by rider A Darmanin and connections of FLYING TO PARIS the second placegetter, against NICCO THE GREEK placed first for alleged interference at about the 200 metres. After viewing the official patrol films, taking evidence from both riders' stewards established that near the 200 metres FLYING TO PARIS had not established a clear run between NICCO THE GREEK and I'M KRUPT. It was the steward's opinion that the FLYING TO PARIS had been held up and then shifted out over the heels of NICCO THE GREEK to improve to a run to the outside of that gelding. Stewards, accordingly, dismissed the protest and declared correct weight on the judge's placings.

**NICCO THE GREEK –** Laid in approaching the 200 metres.

I'M KRUPT - Raced wide until the 1000 metres.

**FLYING TO PARIS** – Rolled in marginally rounding the home turn. Held up approaching the 200 metres.

**CORONATION VERONIC** – Tightened on jumping between I'M KRUPT and FLYING TO PARIS who both shifted ground.

**BLACK EAGLET –** Slow to begin and got his head up and over-raced throughout the early and middle stages.

**GEE GEE MISS QUITA –** Over-raced in the middle stages and had to be restrained off heels approaching the 600 metres.

**FINXY –** Checked off the heels of FLYING TO PARIS entering the home straight.

**ZULU GURU** – Rounding the home turn rolled out marginally carrying CORONATION VERONIC wider, out onto FINXY who was racing tight to the inside of FLYING TO PARIS, which shifted in marginally, as a result FINXY had to be steadied off the heels of FLYING TO PARIS. Stewards spoke to Rider T Baker regarding his fillies disappointing performance. Rider T Baker stated that in his opinion the filly was not up to the rise in distance. A post-race veterinary examination failed to reveal any abnormalities.
