Comments / Explanations:

RACE 1 – 1.05PM – WINNING EDGE PRESENTATIONS MDN PLATE - (1430 METRES)

The start of this race was delayed 3 minutes when a barrier attendant required medical attention from the Doctor and medical staff after being stuck in the head while undertaking her duties. The patient was transported to hospital for observations. by a private vehicle.

1.BOHO STYLE

2.HUNDRED PERCENT- Shifted outwards after the start resulting in the rider having to straighten the mare. A post race swab sample was taken from this winner.

3.IN THE CLOUDS- Became fractious in the barriers. prior to the start and underwent a veterinary examination and passed fit to take its place in the field. A warning was issued to the trainer on the mares' barrier manners.

5.ICE CRYSTAL Jockey Georgie Catania reported on returning to scale that her mount Ice Crystal laid out for most of the home straight resulting in her having to stop riding and straighten the filly.

6.KISSED BY MIST- Was slow to begin and missed the start by 1 length.

Stewards ordered a veterinary examination post race on the filly as she showed signs of lameness post race. The veterinary examination revealed the filly to be lame in the off foreleg and will require a veterinary certificate of soundness prior to being nominated to race or trial.

7.SHESAPIN- Tended to over race in the early and middle stages of the event.

RACE 2 – 1.40PM – KEVIN SHARKIE MAIDEN PLATE - (1200 METRES)

2.RAIDER'S OWN- Raced 4 wide in the early stages.

3.VOSTOK STATION- Bumped at the start by another runner and was slow away. Raced greenly at various stages of the event.

4.ARTILLERY FIRE- Became fractious in the barriers prior to the start and the trainer was advised that a warning was issued on the filly's barrier manners. Jumped inwards at the start bumping another runner.

7.SMIFFY- Stewards questioned the trainer into the improved performance of the filly. Trainer explained that the filly's form is better than what is on paper and at its previous start the rider reported he was happy with the run in the 3yo classic, and it will go better at its next race start. Stewards after reviewing the race accepted the trainer's explanation for future reference.

RACE3 – 2.15PM- AVISO TAS INSURANCE BROKERS MDM PLATE – (1100 METERS)

1.SPARK OF FIRE Jumped awkwardly and was slow into stride. Over raced in the middle stages of the event.

- 2.OUTBUSH Attempted to buck upon jumping and as a result the rider became unbalanced for a short distance resulting in the gelding being slow to muster early speed. A warning will be issued on the geldings racing manners.
- 3.THICKSKINNED Became very fractious in the barriers and was unloaded and examined by the veterinarian. THICKSKINNED was passed fit to rejoin field. Began slowly.
- 4.HEART OF PARIS Shifted outwards under pressure in the home straight when being urged forward with the whip. Hampered another runner because of shifting out under pressure.
- 6.TIGERS ON TOP- Brushed with another runner entering the front straight.
- 8.LADY FERN Laid in and brushed with Tigers on Top on straightening into the front straight.
10. SURPRISE SECRET- The announcement of the correct weight was delayed as apprentice L. Bingley, TIGERS ON TOP, wished to view the official Patrol films. After viewing the official patrol films, Apprentice L Bingley decided not to proceed with an objection and correct weight was declared on the judge's numbers.

Stewards opened an Inquiry into an incident at approximately the 250 meters when apprentice J Radley had to check his mount and was severely hampered. Stewards after considering the evidence tendered at the inquiry and viewing the official patrol films and acting on their own observations issued a charge under provisions of Rule 131 (a) for Careless riding to apprentice J Johnson.

The particulars of the charge were that while apprentice J Johnson was riding his mount out with the whip at the 250m he allowed it to shift outwards when not sufficiently clear of apprentice J Radleys mount resulting in him having to check his mount off heels. Apprentice J. Johnstone was accompanied by senior rider A Darmanin and pleaded guilty to this breach of the rules.

Stewards considered his excellent riding record, and the interference was in the mid-range section and suspended his license for 1 race date. The suspension of Apprentice J. Johnstone will commence at midnight 28th of March 2025 and expire at midnight the 4th of April 2025.

Apprentice Jabez Johnson was reminded of his appeal rights.

RACE 4 – 2.50PM – LADBROKES MATES MODE POTS PLATE – (1200 METERS)

- 1.AL MAXIMUS Shifted inwards rounding the home turn resulting in Rumor Lane needing to be steadied and had to shift outwards over the

heels of the gelding to improve.

3.IBUTHO Over raced early and middle stages and got its head up and raced ungenerously. Needed to be restrained off the heels of Miss Niagara at approximately 1700 meters.

5.GIRLS CLUB Began Slowly and was slow to muster early speed.

6.MISS NIAGARA Tended to lay out under pressure in the home straight.

8.RUMOUR LANE Shifted out under pressure over the concluding stages.

RACE 5 – 3.30PM TASRACING NATIONAL APPRENTICE SERIES 2025
(BM68)(1600 METRES)

1.STONE COLD STUNNER Shifted out under pressure in early stages of the home straight.

2.ZEWINNA Tended to lay in at approximately 200 meters resulting in the rider needing to straighten his mount.

3.STEEL MIST Underwent a veterinary examination post race and no abnormalities were detected.

7.MARTINI BLUE Raced 3 wide throughout the event.

Stewards spoke with apprentice R Mahony about her horse Stone Cold Stunner shifting out under pressure after entering the home straight. After viewing the official patrol films in the company of mentor Peter Hall stewards reminded apprentice Mahony in future when her mount commences to shift ground, she must ensure she stops riding and corrects and straightens her mount.

RACE 6 – 4.10PM KEVEIN SHARKIE HCP – (C1) (1100 METERS)

1.RICH GLOW- Jumped outwards at the start.

7.LA VIRAGO The mare underwent a Veterinary examination behind the barriers as there were traces of blood in its mouth. The mare was passed fit to take her position in the field.
Rolled in under pressure and brushed with Sky Eagle at

approximately 250 meters.

8.WEDNESDAY'S BOSS - Was slow to muster early speed.

Shifted in under pressure over the concluding stages of the event.

Correct weight was delayed when rider M Ulucinar and trainer J Blacker requested to view the official patrol films with view of lodging a protest. After viewing the patrol films rider M Ulucinar did not wish to proceed with a protest and correct weight was declared on the judge's numbers.

RACE 7 – 4.40PM RANVET NATIONAL APPRENTICE SERIES 2025 (BM60)-(1430 METERS)

3.FROM PANTHERLAND Jumped in at the start and brushed with another runner. Rolled in at 1000 meters and bumped Gingerson. With Raced 4 wide for a majority of the event.

4.GINGERSON Was slow to begin and muster early speed away. Over raced in the early stages. Bumped with another runner at the 1000 meters.

5.GEEGEEHAILSTORM Brushed with another runner upon jumping.

7. QUEEN OF MALAWA Disappointed for a run behind Freak on A Lead resulting in the mare needing to shift outward over the heels to obtain clear run.

9. STEEL CONNECTION Fractious in barriers prior to the start. was placed under pressure in the home straight and failed to run on over the concluding stages.

RACE 8 – 5.20PM – LADBROKES RACING CLUB (BM68 – (1100 METERS)

1.MAKE A DECISION Over raced during the early stages. Raced 4 wide throughout.

3.GOLDEN MEADOW Reared on jumping striking the inside barrier partition resulting in the rider becoming unbalanced. Was slow to muster early speed.

4.WARICA Racing to the 500 meters the gelding over raced and got

its head up and raced ungenerously and as a result shifted outwards carrying Eastcoast Mist wider. Was held up for a clear run entering the home straight behind the runners in front.

5.VOLKANOVSKI Stewards granted permission for rider M Ulucinar to ride ½ kg over his allotted weight.

6.EASTCOAST MIST Carried wider rounding the turn at the 500 meters.

7.BELLASARIO Over raced early stages. Got head up and raced ungenerously.

9.SHALL WE PLAY Over raced in the early and middle stages of the event. A post race veterinary examination of the mare revealed the mare to be lame in the off foreleg. The trainer was advised that a certificate of soundness will be required before being nominated to race again.
