After considering the video evidence and taking submissions Stewards were of the opinion it had not breached the rules.

All races were put back one race time after this race, when the lure rollers became jammed with the non-slip tape off the lure rail. The lure was repaired and loose tape removed from the rail. The last race was scheduled for 3.32pm.
