Trainer J k Blacker was fined \$100.00 for presenting two of his horses in the one trail (TISA NICE DROP & OUR PEMENARTIE with the incorrect numbers. AR- 106 (1).

# RACE 1 –10.47AM –CARBINE CLUB BOOK EARLY DERBY DAY - 2YO & UP –(SW) - 1400 METRES

**1. BEAUY'S BOY -** Tended to over race in the early stages. Tightened and checked

rounding the home turn when racing between runners.

**2. EXPOSTAR** Laid inwards making the home turn.

**3. OXY BOLT** Raced 4 wide in the early and middle stages of the event. Forced

wider making the home turn obliging the rider to check off heels.

Rider reported the gelding didn't feel right in its action post race. A veterinary examination revealed no obvious abnormalities at the time of inspection. Trainer will advise on the gelding's action in the

coming days and report to stewards when possible.

**4. TASSIE POWER** Tended to over race in the early stages and restrained to gain a

position closer to the rail.

**5. WOOLCLASSER** Had to be shifted wider on the home turn to gain a clear run.

**6. CURRENCIES** Raced wide in the early and middle stages of the event.

Shifted outwards making the home turn to gain a clear run.

**8. GENUINE LADY** Over raced and laid outwards making the 1200m turn. Raced 5 wide

in the early and middle stages of the event. Carried wider making the home turn. Momentarily held up on straightening and shifted

outwards to gain a clear run.

**9. IN THE CLOUDS** Shifted outwards making the home turn to gain a clear run.

**12. SIENA WOLF** Became fractious in the barriers prior to the start.

**13. SOUTH GEORGIA -** Rolled outwards making the home turn carrying another runner

wider. A post race swab sample was taken from this winner for

analytical testing

Stewards questioned riders Apprentice J Radley (EXPOSTAR), C Jordan (BEAUY'S BOY) and A Darmanin (GENUINE LADY) into an incident rounding the home turn when BEAUY'S BOY had to be checked by its rider when racing between these two runners. After taking evidence from all riders and stewards acting on their own observations and viewing the official patrol films it was established that BEAUY'S BOY who was tiring at this point and EXPOSTAR tended to lay in marginally, at the same time GENUINE LADY moved outwards to gain a clear run, because of the two shifts BEAUY'S BOY racing room was tightened. Jockey C Jordan explained that if she was travelling better, she could have held her position. Stewards could not fully contribute this incident to one rider however reminded both riders to exercise greater care when shifting ground in future.

### RACE 2 – 11.17 AM – BARRY TARANTO CARBINE CLUB LIFE MEMBER MAIDEN – 1200 METRES - 2YO & UP- (SW)

**1. BARRINGTON POWER** Became fractious in the barriers prior to the start.

**5. ORPHAN EAGLE** Bumped by another runner upon jumping. A post race veterinary

examination of the gelding revealed no significant finding at the

time of inspection.

**7. TRIBAL COUNCIL** Began slowly.

**8. COME TO PASS** Tended to over race in the early and middle stages of the event.

**9. PUZZLE MISS**Bumped by another runner upon jumping

**10.STARSET CLOUDS** Raced three wide throughout the event. Shifted outwards

entering the front straight and raced wide.

**11. TIGERS ON TOP** Jumped outwards at the start, bumping another runner

**13. ZULU FIELDS** Raced on the pace outside the leader.

**15. MISS DE LUNE**Jumped awkwardly. A post race swab sample was taken from this

winner for analytical testing.

**16. TAKEAWAY** Jumped outwards at the start, bumping another runner. Raced

wide.

#### RACE 3 – 11.47AM– RON BANKS CARBINE CLUB LIFE MEMBER CLASS 1 HCP - 1200 METRES

**1. OHSHE'TROUBLE -** Began slowly. Failed to run on in the home straight and eased

down over the final 200m. A post race veterinary examination revealed no obvious abnormalities at the time of inspection. Stewards advised the trainer, who was at a loss to explain the performance that due to being uncompetitive the mare will be required to trial to the satisfactory of stewards on 1 occasion prior to being nominated to race again. The trainer further explained that he will be undertaking blood tests to try and find

out reasons why the mare did not perform as expected.

**3. SAY IT WITH WORDS -** Was slow to muster early speed. Restrained at the start at gain a

position closer to the rail. Stewards ordered a post race veterinarian examination as the gelding performed below market expectations. The post race veterinarian examination

revealed no obvious abnormalities.

**8. GEEGEE STRAWBERRY** A post race swab sample was taken from this winner for

analytical testing.

**10. OUR INDULGENCE** Stewards agreed to the rider to ride the gelding ½ kg over its

allotted weight.

**11. NEED TO THINK** Raced 4 wide in the early stages and tended to over race at

various stages. Was held up for a clear run in the home straight and had to shift outwards over heels of another runner to gain a

clear run.

**13. SIR JAG** Had to be re saddled behind the barriers prior to the start of the

event.

#### RACE 4 - 12.22 PM - ROGERSON & BIRCH SURVEYORS CLASS 2 HCP - 1200 METRES

**1. JUST CRUISIN -** A post race swab sample was taken from this winner for analytical

testing.

**2. SCARLETTI** Tended to over race in the middle stages of the event. Had to be

eased by its rider in the home straight.

**5. BAYBOUGG** Became fractious in the barriers prior to the start.

**7. NATVE CLAN** Became fractious in the barriers prior to the start. Raced 4 wide

throughout the event. A post race veterinary examination revealed no obvious abnormalities as the filly failed to run on

over the concluding stages.

**8. WEDNESDAY'S BOSS** Shifted outwards under pressure in the home straight. Rider was

reprimanded for his whip action.

**9. LA VIRAGO** A post race veterinary examination of the mare who performed

under market expectation revealed no obvious abnormalities.

**10. ANGEL SPHERE** Became fractious in the barriers prior to the start.

Stewards questioned Apprentice C Pang in relation to his whip use in the home straight. After taking evidence from the apprentice in the presence of a senior rider and stewards acting on their own observations issued a reprimand to apprentice C Pang under provisions of AR 132 (6) (b) for using his whip in an action that raises his arm above his shoulder height.

#### RACE 5 –12.57 AM - BRIAN HIGGINS CARBINE CLUB LIFE MEMBER 2 YO HCP – - 1200 METRES

**2. GEEGEESDOUBLECROSS** Jumped awkwardly. Inconvenienced in the home straight

because of another horse shifting inwards abruptly.

**3. BRIGHT NIGHT** Laid out under pressure in the home straight.

**4. OUT OF WORDS** Became fractious behind and inside the barrier gates and

proved difficult to load. The trainer was advised that the gelding must complete a satisfactory trial before being

nominated to race again.

**5. DA SILVER FLASH -** Gave ground at the 500m and failed to run on over the

concluding stages.

**6. GEEGEES MERCEDES** Failed to run on over the concluding stages.

**7. WINEYARD** Raced 4 wide throughout the event. Stewards ordered a post

race veterinary examination on the filly as she performed below market expectations and no abnormalities were detected. Trainer was advised that the filly must trial

satisfactorily on one occasion prior to being nominated to race

again.

**8. BELLA CHINKARA** Tightened for room between runners upon jumping.

**9. JENNI THE CAT** Rider reported the filly tended to lay outwards throughout

the event.

**10. MISS LYRA** Tended to over race in the early and middle stages of the

event.

A post race swab sample was taken from this winner for

analytical testing.

**11. ACCUSAIENT** Hung outwards, making the home turn despite the rider's

efforts.

**12. THE PIRATE QUEEN** Raced wide and shifted ground inwards abruptly on several

occasions in the home straight resulting in the rider having to

stop and straighten.

**13. BABY PANDA** Was slow to muster early speed. Post race veterinary

examination revealed no obvious abnormalities.

#### RACE 6 - 1.32 PM - AINTREE ELECTRICAL SAFETY HCP - (BM64) - 2100 METRES

**1. HAPPY CLAN --** A pre race swab sample was taken for analytical testing.

Commenced to over race in the middle stages of the event. Rider

was fined for failing to ride his mount out fully to the line.

**2. PENNINE** A pre-race swab sample was taken for analytical testing.

**3. AL MAXIMUS** A pre-race swab sample was taken for analytical testing. Hung

outwards throughout the event despite efforts from the rider.

**4. SUGOI LEGEND** A pre-race swab sample was taken for analytical testing. A post race

swab sample was taken from this winner for analytical testing.

**5. GODDESS OF ROCK** A pre-race swab sample was taken for analytical testing. It began

slowly and missed it by 1 length.

**6. COUP DE SPRY** A pre-race swab sample was taken for analytical testing.

**7. DOONICAN (IRE)** Stewards agreed to allow the rider to ride the gelding 1kg over its

minimum 54 kg allotted weight. A pre and post race swab sample

was taken for analytical testing.

Stewards questioned Apprentice J Johnson into reasons why he failed to ride his mount out fully to the line as required under provisions of Australian Rule 131 (b). After taking evidence from apprentice J Johnson and senior rider David Pires & viewing the official patrol films, fined apprentice J Johnson the sum of \$100.00. Stewards, when considering a penalty, took into consideration his previous record for this offence.

#### RACE 7 – 2.07 PM – JBM MACCAS CLASS 2 HANDICAP - 1400 METRES

**1. SKIN IN THE GAME -** A post race swab sample was taken from this winner for analytical

testing.

**5. VALIANT KHAN** It became a late scratching at 1.11pm due to the float breakdown.

**6. CARNELIAN ROCK** It became fractious prior to the start and raced wide in the early

stages.

**7. LION'S TOOTH** Underwent a veterinary examination behind the barriers as the rider

reported that she was concerned with the gelding action going to the barriers. Following a veterinary examination, it was passed fit to

take its place in the field.

**8. THIN RED LINE** Raced three wide in the early stages of the event.

**11. I'M KEEFE** Underwent a veterinary examination post race when the gelding

failed to run on over the concluding stages which revealed no

obvious abnormalities.

**12. EMMJAY (NZ)** Momentarily held up for a run making the home turn.

#### RACE 8 – 2.45 PM– STEELINE SHEDS & GARAGES (CLASS 6) – (SW) 1200 METRES

**1. FURNEAUX -** Bounded upon jumping. Over raced in the early stages of the

event.

**3. MAKE A DECISION** Was slow to muster early speed.

**4. RIGOLETTO (NZ)-** Momentarily inconvenienced shortly after entering the home

straight.

**5. TURK BOY** Raced in a three wide position with cover throughout the event.

**6. ANYWAY'S ROXIE** A post race swab sample was taken from this winner for analytical

testing.

**8. ALPINE THUNDER** Raced three wide throughout the event and tended to over race at

various stages throughout the event. Tended to lay inwards under

pressure in the home straight.

**9. CREATIVE LICENCE** Was a late scratching due to a float breakdown.

**10. ESPRIT DIVA** Shifted in abruptly on straightening to gain a clear run. Rider

reprimanded.

Stewards questioned riders L Annells (ESPRIT DIVA) and Apprentice J Radley (RIGOLETTO) into an incident shortly after entering the straight for the run to the finish. After taking evidence from both riders and stewards acting on their own observations and viewing the official patrol films, Jockey L Annells was issued with a severe reprimand. The particulars were that shortly after entering the home straight jockey L Annells shifted inwards abruptly off the heels off the runners in front to get a clear run and when doing so, RIGOLETTO had to be eased of the heels of ESPRIT DIVA who was not fully clear. Stewards when considering a penalty took into account jockey L Annells previous good record and the interference was on the low scale. Jockey Annells was strongly advised of her obligations in similar circumstances.

#### RACE 9 - 3.25 PM - CARBINE CLUB HANDICAP - (WEIGHTS RAISED 0.5 KG) -1400 METRES

**2. WINEGLASS BAY (IRE)** A post-race swab sample was taken from this winner for

analytical testing.

**3. JUST A NEEDS** Stewards agreed for the rider to ride the mare ½ kg over its

allotted 54.5 kg weight. Tended to over race in the early and

middle stages of the event.

**4.GEE GEE MISS QUITA** Stewards agreed for the rider to ride the mare ½ kg over its

minimum 54 kg allotted weight.

#### 8. KABOOM KABOOM

Underwent a veterinary examination behind the barriers prior to the start as the mare struck the running rail on the way to the barriers and passed fit to take her place in the field. Reared upon jumping. Raced three wide in the early and middle stages of the event.

Stewards questioned trainer J Luttrell and Jockey D Pires into the under-market performance expectation of the mare JUST A NEEDS. Trainer and Jockey both explained that the mare was up in class at today's meeting and back in distance and believed the mare didn't finish off the race as they expected although running 4<sup>th</sup> in the event. Stewards were satisfied with the explanations and noted their comments for future reference.

#### RACE 10 - 4.05 PM - COLIN McNIFF FAREWELL (BM60) HANDICAP-1600 METRES

**1. ROWING POWER** Upon jumping it was noticed that the gelding displaced its offside

racing plate.

**2. STEEL MIST** Became fractious in the barriers prior to the start of the event.

**3. RICH CLAN -** Tended to over race in the early and middle stages of the event.

**6. FIORENTE DE LEGEND** Over raced in the early and middle stages of the event.

A post race swab sample was taken from this winner for analytical

testing.

**8. ROMANESCO FRESCO** Tended to lay outwards under pressure in the home straight.
