### General

Flying Winnie completed a satisfactory trial over 340 metres for Failing to Pursue pursuant to GAR 124 with two other greyhounds. Weighing 29.3 Kg and beginning from box 5, this greyhound completed the trial in 3<sup>rd</sup> place in 20.70 seconds and has not been cleared to race as the greyhound failed to run the qualifying time.

Aussie Pablo completed a satisfactory trial over 340 metres for Failing to Pursue pursuant to GAR 123 for Marring with two other greyhounds. Weighing 31.5 Kg and beginning with a box 3, this greyhound completed the trial in 19.55 seconds and has been cleared to race at all tracks.
