Comments / Explanations:

S Nakano's licence application was delayed to asses his fitness to race ride after an extended period of inactivity.

RACE 1 - 12.30 - LADBROKES SRM IN MULTIS BM64 HCP- 2100 M

1. HAPPY CLAN – Raced three wide until 1200m

2. MOORLANDS MISS – Tightened for room near the 100 metres.

3. SUGOI LEGEND – Laid in under pressure near the 100 metres and tightened the running of

MOORLAND MISS which was carried in and tightened AFRICAN THUNDER. Apprentice C Pang was advised he must make more effort to correct his mounts

than he did on this occasion.

6. DOONICAN (IRE) – Crowded near 100 metres.

7. AFRICAN THUNDER - Tightened near the 100 metres.

RACE 2 - 1.05 - LIFE MEMBER MR RON BROOKS MAIDEN/CLASS 1 - 2100 M

1. ALPINE TROUT – Laid in under pressure in the home straight and rider D Pires was unable to ride his mount out in his usual manner.

7. OXY BOLT – Raced three wide to the 1500 metres.

8. SOUTH GEORGIA – Laid in in the home straight and had to be corrected on several occasions.

10. SKELMORLIE - Laid in under pressure over the concluding stages.

RACE 3 - 1.40 - KEVIN SHARKIE MAIDEN- 1400 M

1. BEAU WARRIOR — Over-raced in the early and middle stages.

2. FINAL APPROACH – Raced wide throughout. Laid in under pressure.

3. RAGING WATERS – Raced four wide to the 1000 metres. Laid in onto AZITALA which then crowded the

MOUNTAINEER entering the home straight.

4. THE MOUNTAINEER (NZ) – Crowded entering the home straight and obliged to shift out over the heels of

AZITALA.

6. PLAYED STRONG – Checked and lost its position near the 600 metres when tightened by WARRIORA.

7. SAKURA HIME – Tailed the field in the early and middle stages however ran on late to win. Trainer Y

Nishitani could offer no explanation for the improved performance.

9. TOPAZ MOON – Compounded in the home straight. A post-race veterinary examination revealed a

high heart rate and slow recovery.

11. WARRIORA – Fractious in the barriers. Shifted in from four wide to three wide near from the 600

metres and tightened PLAYED STRONG which was checked out of its position. Apprentice J Radley was charged under the provisions of AR 131(a) for careless riding and reserved his plea. Stewards found Apprentice J Radley guilty as charged and after submission on penalty his licence to ride in races was suspended for 2 Tasmanian race dates. This has been deferred to commence on Midnight the 31st of

August 2025.

RACE 4 – 2.15 – LIFE MEMBER MRS ELIZABETH GEARD MAIDEN- 1200 M

1. CARDIOSPHERE – Shifted out on jumping and the over-raced and laid in.

3. GEEGEES DOWNPOUR – Over-raced in the early stages. Laid in home straight.

4. I'M A MACHINE – Slow to begin.

5. LIGHT FORCE – Laid in under pressure entering the home straight.

8. TOORAK LAD – Laid in approaching the 100 metres, momentarily tightening I'M A MACHINE. Rider E

Byrne Burke was advised to exercise care when shifting ground.

15. RICHARDS – Compounded in the home straight. A post-race veterinary examination revealed no

abnormalities. A warning has been issued on this performance

RACE 5 - 2.50 - AVISO TAS INSURANCE BROKERS CLASS 4 - 1600 M

3. BLONDE STAR – Restrained on jumping to take up a position closer to the rail. Over-raced in the early

stages.

4. DUSTLAND FAIRYTALE – Bumped by FIGHTING FOR GOLD making the 1400 metre turn

6. FIORENTE DE LEGEND – Over-raced making the 1400 metre turn and shifted out bumping with DUSTLAND

FAIRYTALE.

RACE 6 - 3.30 - WINNING EDGE PRESENTATIONS C1 HCP - 1400 M

1. DON'T GIVE UP — Tightened for room when SWANNY DEE laid in over the concluding stages.

2. SWANNY DEE – Laid in under pressure over the concluding stages. Shifted in and momentarily

tightened DON'T GIVE UP near the 150 metres. Rider K Sanderson was advised to

straighten his mounts sooner than he had on this occasion.

6. THEM'S THE BREAKS – Slow to begin.

7. CAPTAIN TAZ (NZ) – Raced wide throughout and over-raced in the middle stages.

RACE 7 - 4.10 - LADBROKES FORM GENIUS BM68 HCP - 1400 M

1. FLYING BILLIE — Apprentice J Johnstone was issued a reprimand for using his whip in consecutive

strides prior to the 100 metres under the provisions of AR 132(7)(a)(i)

3. CHARTWELL HOUSE (IRE) — Checked off the heels of FIGHTING FLOYD shortly after entering the home straight.

7. FIGHTING FLOYD – Slow to begin. Shifted out near the 300 metres when not clear of CHARTWELL

HOUSE which had to be checked off heels. E Byrne Burke pleaded guilty to a charge under AR 131(a) for Careless Riding. After submissions on penalty including her good record and guilty plea her licence to ride in races has been suspended for 1

Tasmanian race date to expire Midnight the 31st of August.

When questioned on the apparent improved performance trainer I Miller stated that

the gelding does mix his form but does perform better at Hobart.

RACE 8 - 4.50 - MINGARI + CO BM66 HCP - 1200 M

1. GOLDEN MEADOW – Slow into stride.

3. STREET DIVA – Laid in over the concluding stages.

4. GINGERSON – Over-raced in the middle stages. Restrained off the heels approaching the 600

metres when SKY LAND shifted into the three wide position. Stewards will inquire

into this incident at the next race meeting.

6. WINNING WITNESS – Over-raced in the early stages.

7. ESPRIT DIVA – A pre-race veterinary examination behind the barriers passed the mare fit to race.

Rider T Baker reported on returning to scale that he felt there was something amiss with Esprit Diva's galloping action however a post-race veterinary examination

revealed no abnormalities.
