| 10. FREIBURG - | Fell due to suffering an injury near the 400 metres without interference. A veterinary examination revealed a suspected spinal injury with paralysis to the hind legs, and the filly was humanely euthanized. Apprentice L Bingley was subsequently transported to Hospital. |

RACE 3 – – LIFE MEMBER MS KIM BOYER MAIDEN- 1600 M

The start of this race was delayed until approximately 2.30 pm due to the ambulance having to remain on course to facilitate the transport of Apprentice L Bingley to hospital for observation.

| 1. RAWABI - | Checked and lost its position near the 150 metres when ARTILLERY FIRE shifted out crowding and checking it onto RARE ORO. Apprentice J Johnstone pleaded guilty to a charge under AR 131(a) Careless Riding for allowing his mount to shift out when insufficiently clear of RAWABI. After taking into account his submissions on penalty and the midrange level of careless and interference his licence to ride in races was suspended for two Tasmanian race dates to commence midnight 7 September 2025. |
| 3. ARTILLERY FIRE - | Shifted out near the 150 metres and crowded and checked RAWABI out onto RARE ORO. |
| 5. RAINBOW ALLEY - | Shifted out when insufficiently clear of FILLENTINA near the 250 metres which had to be checked off its heels. Apprentice J Radley pleaded guilty to a charge under AR 131(a) Careless Riding. After taking into account submission on penalty and assessing the interference and carelessness in the mid-range his licence to ride in races was suspended for two race dates. The dates of this suspension is to be advised. |
| 7. FILLENTINA - | Checked near the 250 metres when RAINBOW ALLEY shifted out |
| 8. RARE ORO - | Tightened over the concluding stages when ARTILLERY FIRE shifted out and tightened RAWABI onto it near the 150 metres. |

| 2. KALI UWAA FALLS (NZ) - | Shifted out marginally and brushed with ASHY BOY near the 150 metres. |
| 3. ASHY BOY - | Tightened for room near the 150 metres. |
| 4. MOVEFORLEX - | Permission given to be ridden 1kg overweight. Over-raced in the early stages. Bumped with KALI UWAA FALLS entering the back straight and carried three wide at this point before shifting back in. When questioned on the below market expectations performance rider D Pires stated that the incident near the 1200 metres had unsettled his mount and was detrimental to its performance today. |
| 9. DUSTLAND FAIRYTALE - | Shifted out near the 150 metres when insufficiently clear of STEEL MIST which had been already tightened from a shift from the outside. Rider T Childs was reprimanded under AR 131(a) for careless riding when assessing the low level of interference to STEEL MIST. |
| 10. STEEL MIST - | Slow to muster early speed. Raced wide in the early stages. Tightened for room near the 150 metres. |

RACE 8 – – LADBROKES FORM GENIUS C2 HCP- 1200 M
