6. AFRICAN THUNDER - Over-raced leaving the home straight.

RACE 2 - LEIGH JORDAN ONE AGENCY COLLINS REAL ESTATE 3YO MAIDEN - 1150 M

1. DON TURBOAS - Shifted in on jumping and bumped with AWESOME ORPHAN.

2. PRINCE OF KHATUN - Laid out under pressure in the home straight.

3. AWESOME ORPHAN - Shifted in under pressure entering the home straight.

4. GOLEA - Passed a pre-race veterinary inspection after contacting the outside

rail and barrier prior to the start.

RACE 3 – LADBROKES QUICK MULTI MAIDEN- 1009 M

2. PENCHANT - Laid out entering the home straight.

4. AFFIRMATIONS - Shifted out over the heels of PENCHANT which had shifted out

marginally.

5. ALPINE DAME - Raced three wide throughout.

6. CLOVER HILL - Raced greenly in the home straight and laid out.

RACE 4 – KEVIN SHARKIE C1 HCP- 1350 M

1. VINO NOVELLO - Raced three wide from the 900 metres. Placed awkwardly on the

heels of GEEGEES DOWNPOUR. When questioned on the

performance today apprentice J Radley stated from a wide barrier he had intended to work forward to a position outside the leader however he was unable to do so and elected to restrain to obtain

cover and the gelding worked home well.

3. SMART ARTIE - Three wide throughout.

5. THEM'S THE BREAKS - Fractious in the barriers and got its head down and delayed the

start. Slow to begin. A warning has been issued for its barrier

manners.

6. RAINBOW ALLEY - Shifted out on jumping and tightened THEMS THE BREAKS.

8. KICKPASS - Slow to muster early speed.

RACE 5 – LENDING 4 U C4 - 1350 M

2. ADACHI - Laid out under pressure in the home straight.

4. CHARTWELL HOUSE (IRE) - Raced three wide throughout.

5. CREATIVE LICENCE - Over-raced in the middle stages.

7. CRAZY ATOM - Tightened between FIGHTING FOR GOLD and WHIPPING

PICCADILLY both of whom shifted ground.

8. FIGHTING FOR GOLD - Crowded and shifted marginally wider near the 600 meters

when CREATIVE LICENCE over-raced and bumped CRAZY ATOM

which in turn shifted.

RACE 6 – TASMANIAN HORSE TRANSPORT C2 HCP - 1150 M

1. GET 'EM WARRIOR - Slow to begin. Over-raced in the middle stages.

2. ONLY OLD ONCE - Raced wide.

3. RED SPHERE - Laid in home straight.

5. KUSINI - Three wide throughout.

Following the running of Race 6, the jockeys with rides in the remaining 2 races approached Stewards with concerns over the lack of visibility due to the continuous rainfall and the track conditions, and concerns with the deteriorating daylight. After consultation, the jockeys were of the view that the conditions made it unsafe to continue and therefore it was decided by the Stewards that the remaining races be postponed.
