General: Due to the postponement of races 4 to 9 from Sunday's meeting (7th September 2025) until today Tuesday 9th September 2025, due to the deterioration of the racing surface through consistent rain, the track was inspected at 10:00am. On inspection the track was found to be suitable for racing. Authorities were informed.

RACE 1 – FEHLBERGS PRODUCE SPRINTLANE – 1609m Mobile

General: Driver D Ford was reminded of his obligations regarding whip action General: Stewards questioned driver J Laugher over the apparent below poor performance of \$1.35 race favorite VOODOO RANGER NZ. VOODOO RANGER NZ, after racing wide for the first 300 metres was positioned in a rearward trailing position near the 1300, before racing three-wide with a trail from the 700, however failed to run on over the concluding stages as may have been expected. Driver Laugher stated he was disappointed with the overall performance, however adding that, in his opinion, the starting price was not reflective of the gelding's ability. Stewards noted the evidence as tendered.

PUNTARNO STRIDE NZ – Leaving the 1300, and approaching the 900, broke gait free of interference. A post-race veterinary examination failed to reveal any abnormalities. PUNTARNO STRIDE NZ was subsequently stood down from racing until satisfactorily completing one re-qualifying trial. Trainer W Yole reported that PUNTARNO STRIDE NZ had struck its sulky wheel with its hind legs during the event.

RACE 4 – CAVALOR EQUICARE TASMANIAN DERBY – 2579m Mobile

CAPTAIN PERFECT – Wanted to shift up the track over the concluding stages, despite efforts from its driver.

RACE 5 – SMITHAWARDS PACE – 2090m Mobile

ONE BIG SHEW – Tended to hang out, while racing into the turns. Disappointed for clear racing room during the run to the finish.
