RACE 1 – FAITHFUL PARK STUD 2YO 1680M – Mobile

QUETZALI – Hung inwards at the 400m and raced inside one marker peg and contacted another.

BRIDWOOD MAISEY – Raced greenly leaving the back straight on the final occasion where she went inside several marker pegs, and again when she drifted up the track and made the home turn away from the peg-line. Driver Mitch Ford advised stewards that he will speak to the stable about making a gear change before the fillies next race start.

WHERESTHESAVS – Shied in the home straight to get the bell

HEZA RIPPER – Out of position at the start and raced roughly

RACE 2 – THE BOTTLE-O HADSPEN PACE 1680M – Mobile

EVERYTHING BUT THE – Broke gait at the 300m. The gelding will be stood down pending the completion of a satisfactory trial

CUZZY JUNIOR – Back in the mobile barrier draw

RACE 3 – BOOK YOUR CHRISTMAS PARTY 2200M – Mobile

No racing incidents

RACE 4 – TASSIE GOLDEN APPLE SATURDAY 29 NOVEMBER 1680M - MOBILE

STITCHED UP DAN – Was tightened by Ruebe Starbuck, forcing the driver to check ,and as a result contacted a marker peg racing into the first turn. Gave ground from the 300m mark. A post-race vets examination revealed no abnormalities. Consequently, the mare was stood down until the satisfactory completion of a trial.

CANNON BEACH – Lost a shoe. Gave ground from the 500m mark. A post-race vets examination revealed ‘hopple rub’. Notwithstanding the vets finding, the gelding will be stood down until the satisfactory completion of a trial.

HAY MIKI – Out of position at the start. Stewards reprimanded driver Malcolm Jones under rule 162(1)(j) for failing to maintain his position behind the starting gate until the start.

ROSE NOIR – Gave ground from the 300m mark. Placed on its last chance to race competitively.

General – Stewards inquired into the reasons for stitched Up Dan being tightened in the run to the first turn. Stewards spoke to drivers Dyland Ford and Jordan Chibnall. After viewing the patrol footage and acting on their own observations, stewards fined driver Jordan Chibnall \$200 under rule 168(1)(a) for driving in a careless manner. The particulars being that she was not a full meter clear of Stitched Up Dan when crossing in the run to the first turn.

RACE 5 – FIND US ON FACEBOOK 1680M – Mobile

General – KENYA was declared a late scratching at 4.33pm by order of the vet after arriving oncourse with an abscess on its neck

JUST MIKI – Raced roughly at various stages of the event. A post-race vets examination revealed lameness in the left foreleg due to a burst abscess and a heart murmur – the vet recommended the mare undergo further tests before racing again. Notwithstanding this, stewards spoke to trainer Connor Crook who could offer no other excuses for the mares’ performance.

RACE 6 – LADBROKES QUICK MULTI PACE 2200M – SS

KNOCK OUT – Began badly, placed on its last chance in the standing start draw

ONE OF THE LADS – Underwent a pre-race vets examination and was passed clear to run.

COLBY SANZ - Began badly, placed out of the standing start draw. Inconvenienced at the first turn when We Salute You shifted away from the marker pegs. Raced ungenerously for a short distance afterwards.

WILL HE PIKE - Began badly, placed on its last chance in the standing start draw

DENNY - Began badly, placed on its last chance in the standing start draw

General – Stewards spoke to driver Mitch Ford with regards to an incident at the first turn when Colby Sanz was inconvenienced. After watching the patrol footage, it was noted that the pace had slackened considerably in the one-wide line which played a major part in Mr Ford not being able to execute the shift cleanly. Notwithstanding this, Mr Ford was reminded him of his obligations when shifting.

RACE 7 – LADBROKES MATES MODE POTS PACE 1680M – MOBILE

TAMBROS TILLY – Was held up for clear running until the latter part of the home straight.

EAGLE WATCH – Broke gait racing into the first turn. Placed on its last chance in the draw. Raced ungenerously at various stages

SUGARPOVA – Tightened for racing room at the 400m when Hammer Dan shifted away from the marker pegs and locked wheels with Wavethebill to its outside

LETSGOBRO – Back in the draw for future mobile events.

General: Stewards reprimanded driver Dylan Ford under rule 168(1)(a) for driving in a careless manner. The particulars being that he shifted away from the marker pegs causing his wheels to momentarily lock with Jordan Chibnall's(Sugarpova)

RACE 8 – LADBROKES ODDS SURGE STAKES 2200M – MOBILE

TRIPLE VINNIES – Momentarily tightened and contacted marker pegs at the first turn when Maddis Tiger shifted in. Held up in the early part of the home straight

KEAYANG FITZY – No clear run

VANQUISH STRIDE – Held up until the latter part of the home straight

RACE 9 – VIZPIX BROADCAST STAKES 2200M – MOBILE

I WANT IT ALL – Gave ground

CINOCAL JAMANE – Gave ground and placed on its last chance to race competitively. A post-race vets examination revealed no abnormalities.

MACH ANGELO – Gave ground. Out of position at the start. Driver Liam Older was reprimanded under rule 162(1)(j) for failing to maintain his position at the start

General: Stewards spoke to stable representative Bronte Miller with regards to the manner of Arma Rolling Stones winning performance this evening. Ms Miller explained that she was not surprised by the win as the horse had been racing very well in recent starts despite enduring some very tough runs from the breeze, and from unsuitable barrier draws. She further explained that the horse 'grows a leg' when able to lead in its races and that he was able to find that spot with relative ease tonight. Stewards advised Ms Millar that it would be expected that the horse would hold that level of form in future starts, given similar racing circumstances.
