## Comments / Explanations:

Beau Treloar was unable to make the weights today. Stewards will inquire into the reasons for Apprentice Treloar being unable to fulfill his riding engagements.

Anthony Darmanin was declared unfit to ride after race 1 and must provide a medical certificate prior to riding again.

Stewards acceded to a request by Trainer Glenn Stevenson for K Sanderson to ride Asva in race 7 as there were no comparable apprentices.

## RACE 1 -IDI BOUTIQUE BM 68 HANDICAP - 1350 M

**3. RUBBLEONTHEDOUBLE** Slow to begin. Stewards continued a warning on the geldings pre-race manners as

it proved difficult to bring to the mounting yard. Any further difficulties in

parading the gelding will result in it being stood down to a trial.

**1. ADACHI** Laid out making the 600 metre turn and under pressure in the home straight.

**5. ALPINE BLAST** Laid out under pressure in the home straight.

#### RACE 2 - LEIGH JORDAN ONE AGENCY COLLINS REAL ESTATE 3YO MAIDEN - 1150 M

**6. OCCASIONAL GLIMPSE** Rider reported saddle slipped in the home straight and he could not ride his mount

out to the end of the race.

**1. CALLED THROUGH** Bumped with HARRATA on jumping. Raced three wide throughout.

2. HARRATA Shifted out on jumping and bumped with CALLED THROUGH. Laid in in the home

straight rider Kirra-Lee Lane was unable to ride her mount out fully. A post-race

veterinary examination revealed no abnormalities.

7. TIZSA NICE DROP Bumped by HARRATA shifting out on jumping. Laid out under pressure in the

home straight.

#### RACE 3 - LADBROKES QUICK MULTI MAIDEN- 1009 M

**6. DENHAM BAY** Proved difficult to load. Laid out making the 600 metre turn and carried PENCHANT

wider.

**5. SWING LOW** Shifted wider to progress around PENCHANT and over-reacted and made the turn

wide.

9. WHO'S IN DEV Laid in entering the home straight.

#### RACE 4 - KEVIN SHARKIE C1 HCP- 1350 M

**5. ZOETE'S ROCK** Rider given permission to ride 1kg over the allotted weight as there were no suitable

riders at the weight. Slow to begin.

**2. CREATIVE LICENCE** Fractious in the barriers.

**6. ONLY OLD ONCE** Slow to begin. Lodged a protest against SKYLAND being declared in a dead heat for

second place with it. The grounds for the protest alleged interference near the 250

metres when SKYLAND shifted in and hampered it on two occasions. After

considering the interference suffered to Only Old Once and the margin at the finish

Stewards upheld the protest and amended the placings accordingly.

**4. SKYLAND** Laid in near the 250 metres and crowded the running of ONLY OLD ONCE on two

occasions. Rider S Tsaikos pleaded guilty to a charge under AR 131(a) for Careless Riding. After taking into account his submissions on penalty S Tsaikos's licence to ride in races was suspended for 1 Tasmanian race date. The commencement date of

the suspension will be advised after Mr Tsaikos considers a deferment.

#### RACE 5 - LENDING 4 U C4 - 1350 M

7. COOL HEART Slow to muster early speed. Shifted out near the 200 metres and bumped

OHSHESTROUBLE.

**10. ANGELS SPHERE** Shifted out on jumping and bumped with OHSHESTROUBLE.

**5. LORD WHITEGATE** Held up for a clear run near the 350 metres and then had to shift to the inside of

AMANT FRANCAIS to obtain clear running.

**6. OHSHE'STROUBLE** Laid in entering the home straight and then COOL HEART shifted out and bumped

with the mare carrying it wider on the track.

### RACE 6 - TASMANIAN HORSE TRANSPORT C2 HCP - 1150 M

**8. NO ACCESS** Held up entering the home straight.

**6. MYWORDIS** Raced three wide throughout.

**4. EXALTED CROWN** Jumped awkwardly, over-raced in the early and middle stages.

**7. GEE GEE CAN WIN** Slow to begin.

#### RACE 7 - THE STABLES AT SPREYTON BM68 HCP - 1150 M

**4. BLONDE SUSPECT** Slow to begin and raced three wide throughout.

**6. MIGHTYMAXI** Raced three wide in the early and middle stages.

**7. AFRICAN THUNDER** Failed to respond when placed under pressure in the home straight. A post-race

veterinary examination revealed swelling and mild pain in the near foreleg. A veterinary clearance will be required before the gelding trials or races again.

#### RACE 8 - GOODSTONE GROUP MAIDEN/CLASS 1 - 1880 M

**7. KICKPASS** Declared a late scratching at 3.06pm when there was no available rider.

**8. RUBICKS AFFAIR** Commenced to over-race leaving the home straight and then tightened marginally

when I'M CHEV shifted in.

**2. I'M CHEV** Shifted in near the 1400 metres tightening RUBICK'S AFFAIR rider C Jordan was

advised to exercise more care when shifting ground.

**6. CAPTAIN TAZ (NZ)** A post-race veterinary examination revealed mild colic and slight dehydration. A

veterinary clearance will be required before the gelding trials or races again.
