RACE 1 – LADBROKES BIG BETS PACE 1609M – Mobile

HEZA RIPPER – Broke in the score up and was out of position at the candy pole. Will be excluded from future mobile draws

QUETZALI – Raced erratically at various stages

ZAV DAN – Gave ground

RACE 2 – FEHLBERGS PRODUCE SPRINTLANE PACE 1609M – Mobile

UNOBETTER – Inconvenienced on the home turn when Stepupndance broke gait

SHADES OF SILK – Broke under pressure coming the to the home turn and checked a number of runners. Last chance to race truly

VINCENTS RAINBOW – Severely checked and broke when Shades Of Silk broke gait approaching the home turn. No action taken

MY BAD –_Checked by Shades of Silk when that horse broke gait approaching the home turn

STEPUPNDANCE – Broke under pressure in the home straight. Last chance to race truly

RACE 3 – DOWNBYTHESEASIDE@WOODLANDS STUD PACE 2090M – Mobile

No racing incidents

RACE 4 – REGISTER FOR THE DYNAMO PACE 1609M - MOBILE

PHOTO FIRST_– Broke a connecting hopple strap shortly after the start and broke gait. The gelding was then retired from the event. No further action taken

SHARMEY – Was inconvenienced when Photo First broke gait

LOUTENANT – Gave ground from the 400m. Placed on its last chance to race competitively.

BUSLOAD OF FAITH_– Broke in the score up and was out of position at the start. Took no competitive part in the event. Will be excluded from future mobile draws

RACE 5 – PRYDES EASIFEED PACE 2090M – Mobile

CHENIN BEACH_– Was held up early in the straight

WILL HE PIKE_– Used the sprint lane

ARDEN ROANOKE_– Pulled hard and gave ground from the 500m. A post-race vet exam revealed no abnormalities

RACE 6 – LADBROKES QUICK MULTI PACE 1609M – Mobile

RUBINS PLIGHT – A post-race vet exam revealed no abnormalities

RACE 7 – LATHER UP STANDING @WOODLANDS STUD PACE 2090M – Mobile

LUVTHAT – Contacted a number of marker pegs racing into the back straight on the first occasion. Driver Dylan Ford was fined \$50.00 under rule 163(1)(c)(ii)

SHOOBEES STAR – Was inconvenienced by the tiring Rose Noir at the 700m. The gelding was held up for clear running for the majority of the home straight. Query driving tactics

ROSE NOIRE – Gave ground from the 700m. The mare was stood down for poor performance and will have to trial satisfactory before racing again.

SAPPHIRE GAMBLER – Used sprint lane

General – Stewards queried the drive of Jack Watson (Shoobeys Star). In particular his reasons for shifting back to the inside of Moneys No issue at the 600m after initially shifting three-wide to race on that horses' back, resulting in his horse being held up for clear running until the latter stages. Mr Watson put forward that his drive only has a very short sharp sprint and as such needs an economic run. He drove the horse in a similar manner to win on the 21st of September. In his opinion when he made the decision to switch back to the inside of Moneys No Issue, that horse was not progressing and would not carry him into the race. He felt he would be able to shift that horse wider as he progressed further into the final bend but was surprised when that horse stayed on so well over the concluding stages. Stewards accepted Mr Watsons explanation, and he accepted the stewards view that the better percentage play would have been to remain in a three-wide position and shift wider further into the race.

RACE 8 – MOREYS TOURS PACE 2090M – Mobile

After runners completed their warmup laps, driver Jack Watson reported to the stewards that he wasn't happy with Napattack Sams' action. A vet exam was subsequently performed, and the gelding was withdrawn from the event on veterinary advice due to lameness at 8:50pm. A 10 day stand down period was imposed

YURUGA LASS – Hung in at the 800m and contacted a number of marker pegs.

The mare was tightened for racing room between Cougar Express and Royal Reactor at the 400m when attempting to shift away from the marker pegs. This resulted in driver Jacob Duggan having to restrain back to his position on the marker pegs checking Rock On Playboy who broke gait.

Went inside a marker peg in the home straight when tightened by Cougar Express who shifted slightly inward shortly after straightening. Before declaring all-clear stewards viewed the footage and felt that it had no material effect on the result of the race.

COOLANDCOLLECT – Shifted out under pressure in the home straight

General – Stewards charged driver Jacob Duggan under rule 168(1)(a) for careless driving and issued a \$100 fine. The particulars being that Mr Duggan shifted away from the marker pegs to take a run between Cougar Express and Royal Reactor when there was insufficient room, resulting in him having restrain his horse and checking Rock On Playboy who broke gait.
