## <u>General</u>

Buckle Up Gavin completed a satisfactory Stewards trial over 278M for marring with two other greyhounds. Weighing 32.5 Kg and beginning from box 3, this greyhound completed the trial in 16.23 seconds and has been cleared to race at all tracks to 340 metres.

Lyncar Lionel completed a satisfactory Stewards trial over 278M for marring with three other greyhounds. Weighing 35.5 Kg and beginning from box 5, this greyhound completed the trial in 16.90 seconds and has not been cleared to race as the qualifying time was not met.
