RACE 1 - LADBROKES PUNTERS ASSIST PACE - 2180m

Leaving the back straight on the first occasion, GLENVIEW LANAKI (L. Older) raced roughly, and a warning was issued.

Reins person M. Yole (ISLA ATHENA) was fined \$100 under AHR Rule 162(1) www(iii) for allowing his horse to shift wider on the home turn, advantaging and allowing STANTON BREAK to obtain an inside run.

Stewards spoke with licensed person D. Rand regarding comments made to reins person D. Ford after the race and reminded him of his obligations.

RACE 2 – TREVOR AND MARJORIE LEIS PACE – 2180m Mobile

All clear was delayed allowing D. Ford (LUVTHAT) placed 5th to view the film of the home turn on the final occasion. After viewing the film, all clear was given.

Home turn final occasion LUVTHAT raced in restricted room while attempting a run to the outside of ORAVOIR.

HAY MIKI Trainer M. Jones underwent a pre-race veterinary examination and passed to start, however Stewards informed Mr. Jones of report from the veterinary officer in respect to the condition of the horse, and instructed he monitor closely its well-being.

Trainer B. Heenan was fined \$50 for failing to notify Stewards her runners were in care of M. Ford at today's meeting. AHR Rule 90A(2.10)(d).

RACE 3 – 7 TASMANIA PACE – 2180m Stand

PUNTARNO STRIDE (G. Rattray), which commenced poorly, will be excluded from the draw in future standing start races.

Warnings were placed on DONE WELL (T Ford) and DAZZLE ME (L. Older) which commenced poorly.

A warning placed on TULLAH GIRL (C. Castles) which galloped leaving the back straight on the first occasion.

The offside sulky tyre on TULLAH GIRL deflated in running.

A post-race veterinary examination of TULLAH GIRL revealed lacerations to near fore fetlock which was treated and on veterinary advice the mare will be stood down 14 days and require a veterinary clearance prior to its next engagement.

RACE 4 – 7BU: CELEBRATING 90 YEARS ON THE AIR PACE – 2500m Stand

COLBY SANZ, Trainer K. Rattray underwent a pre-race veterinary examination as it had reared and struck its head in race day stall and was passed fit to start.

ASHANTE QUEEN (B. Davis), which commenced poorly, will be excluded from the draw in future standing start events.

NANCESTIGER (C. Castles) commenced slowly and raced roughly after the start.

The lugging pole on SAPPHIRE GAMBLER (L. Older) became detached in back straight on the first occasion.

RACE 5 – ALPHA ELECTRICS & WATER PACE – 2180m Stand

Warnings placed on MORRIS BROWN (Rattray) and TWILIGHT BEACH (D. Ford) which commenced poorly.

A warning was placed on NO NUKES SKIPPER (M. Ford), which galloped approaching the home on the turn final occasion and whilst in a gallop broke the near side hopple loop.

RACE 6 – LADBROKES POPULAR SRM PACE – 2180m Mobile

Trainer T. Langley was fined for presenting VINCENTS RAINBOW with incorrect gear. AHR Rule 273(6)(b).

RACE 7 – MA & LJ BATES PLUMBING PACE – 1892m Stand

Following the release of race fields, it was established CINOCAL JAMANE had been drawn as ODS when eligible to be included in draw, therefore a re draw was done.

Warnings were placed on CINCOCAL JAMANE (M. Ford) and NIKITA JO (D. Ford) which both commenced poorly.

QUEENOFDANCE (H. Van Dongen) delayed the start and commenced poorly. As such, will continue to be excluded from standing start draws.

A warning was placed on OUR RUBY ROSE (G. Rattray) which galloped in the back straight on the final occasion, severely checking CINCOAL JAMANE (M Ford).

RACE 8 – RIDGETECH PACE – 2180m Mobile

A false start was called when MISS CRUNCHY (H. Van Dongen) galloped approaching the start, checking runners on second line and will be excluded from future mobile barrier draws.

A further false start was called when HORRIE OTARA (B. Davis) had its head under mobile arm and TAKING A PUNT (D. Ford) broke gait and shifted inwards, checking JADEZ (T. Rattray). Considering the previous false start, no action was taken.

MISS CRUNCHY galloped when start was affected and will now be excluded from future mobile barrier draws.
