Trainers with multiple runners in a race advised Stewards of intended tactics.

Sprint lane in operation.

Following race two all drivers were advised that bell lap siren was not working.

RACE 1 - LADBROKES BIG BETS PACE - 1609M MS

A warning was placed on TISU JACK HIGH (B. Davis) which galloped in the front straight on the first occasion.

A warning was placed on QUAY (T. Rattray) which hung inwards approaching the home turn on the final occasion, tightening the racing room of IYLAC CHAMBER (M. Ford) down onto marker pegs.

The lugging pole on IYLAC CHAMBER was examined by Stewards following the completion of the race and was found to be in satisfactory condition.

BRIGHTLY BLAZE (J. Duggan) utilized the sprint lane to win the race.

RACE 2 – PRYDES EASIFEED PACE – 1609M MS

The bell lap siren didn't activate; however, no driver was affected.

RACE 3 – TASMANIAN HORSE TRANSPORT PACE – 2090M MS

Approaching the home turn on the final occasion DENNY ROCKS (T. Ford) hung up the track and locked wheels with KIAVINO STRIDE (H. Van Dongen).

RACE 4 - LATHER UP STANDING @ WOODLANDS STUD PACE - 2090M MS

POST LAZARUS (L. Older) which galloped approaching the back straight on the first occasion will be stood down from future engagements until it completes one satisfactory trial.

Stewards fined reins person J. Quinlan (DENVER MAN) \$200 for allowing another person to be mounted on sulky following the post-race winners photo.

RACE 5 – THE DYNAMO 14TH NOVEMBER PACE – 2090M MS

POWER UP (D. Ford) contacted marker pegs on the home turn on the final occasion prior to entering sprint lane, however Stewards were satisfied it had not gained any advantage.

SMOKESCREEN (R. Hillier) and RUBINS PLIGHT (H. Van Dongen) were held up for clear running entering home straight on the final occasion.

RACE 6 – LADBROKES QUICK MULTI PACE – 2090M MS

No racing incidents.

RACE 7 – SMITHAWARDS PACE – 2090M MS

COOLANDCOLECT (R. Duggan) which galloped shortly after the start, will be excluded from future mobile barrier draws, and a warning was issued for galloping in the back straight on the first occasion.

A warning was placed on THE GANG (D. Ford) which paced roughly after the start and then galloped leaving front straight shortly after.

YARECKON IM SWEET (L. Older) which galloped leaving the front straight will be stood down until completion of one satisfactory trial.

The deafeners on BUSLOAD OF FAITH (G. Rattray) failed to release.

RACE 8 – FEHLBERGS PRODUCE SPRINTLANE PACE – 2090M MS

FIVEFORTY (P. Willams) and COUGAR EXPRESS (A. Collins) both of whom performed poorly placed on last chance to race competitively.

Following running of race reins person was dislodged from sulky on way back to race day stalls and required attention from Medical Edge officials. Acting on advice from the officials he was stood down from his drive in Race 9 as he was receiving treatment however no medical clearance required.

RACE 9 - MOREY'S TOURS PACE - 1609M MS

JUSTIFY (H. Van Dongen) started as Extreme Outside Draw in barrier seven.

Stewards approved A. Collins to replace injured R. Hillier on YELLA.
