Trainers with multiple runners in a race advised Stewards of intended tactics.

Sprint lane in operation.

General.

A swab test on stable hand Ben Said revealed a non-negative result and after hearing evidence of medication he has been subscribed on medical advice inquiy adjourned to confirm this advice.

RACE 1 - EAST COAST COACHES PACE - 2090M MS

A warning was placed on WAZZA (D. Ford) which hung up the track shortly after the start and inconvenienced Southern LUCK (J. Watson).

A warning was placed on BETTABLACK TIGER (C. Castles) which shifted up the track over the concluding stages. Reins person C. Castles was also reminded of his obligations when his drives are shifting ground.

#### RACE 2 – LATHER UP @ WOODLANDS STUD 3YO FILLIES CHAMPIONSHIP – 2090M MS

GOT THE GLOW (M. Yole) which galloped shortly after start will be excluded from draw in future mobile start races.

SMOOTH REASON (R. Hillier) utilized sprint lane to win the event.

#### RACE 3 – WOODLANDS STUD EVICUS FINAL – 1609M MS

BRIDWOOD MASEY (M. Ford) underwent a veterinary examination after completing its preliminary as it had some blood in its mouth. Passed fit to start.

When questioned in respect to his tactics of issuing a challenge to BRIDWOOD MAISEY (M Ford) after start where a 27.3 second first quarter was run prior to his filly breaking gait when being restrained. Mr. Ford stated that in his view pre-race the best chance was to contest the lead as having driven BRIDWOOD MAISEY in trial where it had tendency to race roughly when pressured. Stewards informed Ford that in their opinion whilst his tactics were open to question he may have perhaps been better served to restrain earlier.

Stewards charged D. Ford (DAISYPEA) with driving in a careless manner that whilst his horse was in a break he moved it back towards the racing line resulting in trailing runners being inconvenienced. R 168 (1) (a) He pleaded guilty to the charge and after considering his previous driving record his license was suspended for three Tasmanian race dates.

Stewards adjourned an inquiry into an incident in the race day horse stalls as they will be viewing video footage. The following people will be required to attend this inquiry. Ben Said, Nathan Ford, Dylan Ford, Mitch Ford, Phillip Ford and Bianca Heenan.

Stewards was approached by owner Richard Hall after the race, and he was informed Stewards would advise him of inquiries in the race.

TWIGHLIGHT STORM (J. Chibnall) utilized sprint lane to win the race.

#### RACE 4 – TUNNACK COMMUNITY CLUB CLASSIC PACE – 2090M MS

When questioned J. Watson (OH NO NEVER AGAIN) stated that he was unable to restrain his drive as he would have desired as it over raced.

The reins persons license of Tiarna Ford (STIR ME UP) suspended for one Tasmanian race date after pleading guilty for a charge of contributing interference to TOP GUN TED (L. Older) near 250 Meters. R 163 (1) (a) (iii).

A post-race veterinary examination of DENVER STRIKE (C. Salter) which led and gave ground to be beaten 171 Meters revealed no abnormalities. Trainer W. Watson advised will be stood down until it completes a satisfactory trial.

MUZZAME MATE and JUSTIFY reinstated in draw mobile barrier start events.

#### RACE 5 – WOODLANDS STUD DANDY PATCH FINAL – 2090M MS

QUAY (L. Older) hung inwards and contacted marker peg home turn final occasion. Ww. wA

#### RACE 6 - BUCKLAND STORE - SHELL PACE - 2090M MS

RAKADAN (J. Watson), which was out of position at start will be excluded from draw in mobile barrier start races.

ONE BIG SHEW (J. Duggan) utilized sprint lane to win the race.

#### RACE 7 – BRONZED NAILS & BEAUTY PACE – 1609M MS

No racing incidents.

#### RACE 8 – SPOT ONN PAINTING PACE – 2090M MS

The reins person license of D. Ford (POWER UP) was suspended for two race meetings after pleading guilty to a charge of crossing WILL HE PIKE (J. Duggan) leaving winning post shortly after start when it was not clear of that gelding. R 163 (1) (a). In assessing penalty Stewards considered guilty plea, previous driving record and degree of interference which was in mid-range. Penalty to be served cumulatively with previous suspension in race 3. Checked in incident were WILL HE PIKE, NOVA BAXTER and MISTA EAGLE.

#### RACE 9 – LADBROKES BIG BETS PACE – 1609M MS

DENVER MAN (C. Salter) which galloped as start effected will be excluded from draw mobile barrier start races.

A warning placed on HORATIUS SPECULO (D. Ford) which shifted ground up the track over concluding stages.

A warning placed on PERFECT CUT (J. Duggan) which gave ground to be beaten 109 Metres.

Stewards advised M. Ford (ARMA ROLLING STONE) to ensure his body is always inside confines of sulky. R 170 (2).
