RACE 1 - LADBROKES BIG BETS PACE - 1680M MS

No racing incidents.

RACE 2 - FIND US ON FACEBOOK PACE - 1680M MS

A warning placed on VINCENTS RAINBOW (D. Ford) which galloped in back straight final occasion.

SUES PASSION (G. Rattray) paced roughly shortly after start and in run to finish.

PHLOW JO (T. Rattray) paced roughly front straight first occasion.

IDEN ELIZA JANE (C. Salter) hung outwards over concluding stages.

RACE 3 – TASSIE GOLDEN APPLE 29 NOVEMBER PACE – 2200M MS

Stewards cautioned H. Van Dongen (BARNY BILL for not maintaining position at start. R 162 (1) (j).

GLENVIEW LANIKAI (L. Older) momentarily paced roughly approaching the start.

MOVESLIKEALADY (R. Hillier) inclined to lay in over concluding stages

Reins person B. Davis (KOSTYUK LEIS) fined \$100 for using whip in more than a flicking motion. R 156 (2) (a).

RACE 4 – VICTORY IMAGES PHOTOGRAPHY STAKES – 1680M MS

Stewards gave permission for MISS CRUNCHY to race without tongue tie as it had become fractious, and it was unable to be fitted. MISS CRUNCHY (D. Ford) underwent a pre-race veterinary examination after throwing itself down on the track and was passed fit to start. A post-race veterinary examination of the filly revealed no abnormalities.

RACE 5 – TASSIE WASH STAKES – 2200M MS

The offside guider on MORRIS BROWN (T. Rattray) broke near 400 Metres. Gear inspected and found to be of good quality.

GOODTIME OSCAR (D. Ford), RAGING ON (J. Chibnall) and GOBSMACKED (L. Older) all held up for clear runs approaching front straight final occasion.

RACE 6 – LADBROKES BLACKBOOK STAKES – 1680M MS

Reins person J. Chibnall (KNOCK OUT) cautioned for way she shifted ground outwards near the 800 Metres which inconvenienced DIAMONDSAREBLUE (D. Ford).

Reins person M. Ford (ANDAMAN BAY) fined \$50 for contacting and puncturing offside sulky tyre of DENNY (G. Jones) near 800 Metres. R 168 (1) (a).
