General – Prior to the meeting stewards conducted an inquiry into a report that was received regarding two social media posts made by licensed Owner, Trainer and Breeder Gerard Allford on the Facebook group 'Save Greyhound Racing in Tas". After reviewing the relevant posts stewards issued a charge under rule 165(a) – Conduct detrimental to the interests of greyhound racing. Mr Allford offered a Not Guilty plea, however Stewards found Mr Allford guilty as charged. The particulars being that Mr Allford made two separate posts on the Facebook group 'Save Greyhound Racing in Tas" that were prejudicial to the interests and image of greyhound racing. Stewards issued a fine of \$2000 with \$1000 suspended for 24mths reliant on Mr Allford not re-offending under this rule, or similar, during that period.

In arriving at Penalty, Stewards took into account all available evidence including Mr Allford's submissions, his disciplinary history, and that Tasracing has made concerted efforts to educate all stakeholders and participants on Respectful Behaviours and appropriate use of Social Media

During the inquiry Mr Allford misconducted himself by using obscene and/or improper language towards and/or in relation to stewards. Mr Allford was charged under rule 165(c)(iv) to which he pled Not Guilty. Mr Allford was found Guilty and fined the sum of \$250.00

Frosty Lad was presented to kenneling 1.1kg over his last racing weight. Consequently, he was made a late scratching and trainer Anthony Bullock was fined the sum of \$200.00 under GAR 101(3)(b). In determining penalty stewards considered Mr Bullocks poor recent record with regards to this rule.

A post-race vet examination of FRANKY FERRARI revealed minor spike wounds to left metatarsal region. A 3-day stand-down period was imposed

A post-race vet examination of BONTA revealed a laceration to the dew claw. A 5-day stand-down period was imposed

A post-race vet examination of MAGIC BOOM revealed a minor spike wound to the right fetlock. A 3-day stand-down period was imposed

A post-race vet examination of BUCKLE UP GAVIN revealed a mild reactive right distal – back muscle region. A stand-down period of 21 days was imposed.

Stewards spoke to trainer Robyn Johnson regarding the racing manners of BUCKLE UP GAVIN in the home straight. After watching the patrol footage and acting on their own observation's stewards determined that BUCKLE UP GAVIN made muzzle contact with BONTA in the home straight. Consequently, a suspension of 28 days at all tracks was imposed under GAR123 for marring (second offence), and until the completion of a satisfactory
