Whilst acknowledging that MONEYS NO ISSUE had lost momentum when SHOOBEES SPIRIT shifted out wards there after on the home turn it shifted out and continued to so in home straight of its own accord and Stewards were satisfied that placings should stand. A caution was issued to J. Watson for manner he shifted ground. R 163 (1) (a) (i).
