# Comments / Explanations:

Stewards accepted the reason for the late declaration of rider in race 2.

#### RACE 1 – LIFE MEMBER MR.ROSS BURRIDGE AM - 1200M

**2 COLONEL BOGEY**Rider B Muhcu reported his mount failed to muster speed in the

early stages and settled further back than he had anticipated. He further reported that in his opinion the gelding may be better

suited with the addition of blinkers.

**4 LAWRENNY BOYS** Bumped with SUNRISE AT KIRRA on jumping.

**6 SAVAGE RIVER** Leaving the 100 metres was inclined to lay in under pressure.

**7 THE LITTLE BAY** Shortly after the start bumped by SUNRISE AT KIRRA which shifted

out after bumping with LAWRENNY BOYS.

**10 SEDNA** Raced wide without cover throughout.

**11 SOUTHERN AURORAS** Was inclined to lay in under pressure in the home straight.

**12 SUNRISES AT KIRRA** Bumped with LAWRENNY BOYS on jumping away and shortly after

shifted out bumping THE LITTLE BAY. Shortly after the start commenced to buck and was eased out of the race. Trainer R Hall was advised that the mare will not be permitted to race until it trials to the satisfaction of the Stewards on one occasion.

**13 CARRASOUILLO** Proved difficult to load, resulting in the rider having to dismount.

Trainer J Keys was advised that the filly will not be permitted to race until it barrier trials to the satisfaction of the Stewards on one

occasion.

**14 MISS ESS** Laid out rounding the home turn.

**18 SAMASH'N'GRAB** Over the concluding stages was obliged to shift out and away

from heels to obtain clear running.

#### RACE 2 – LIFE MEMBER MR CAM SORELL MAIDEN - 1400M

**2 LORD HEAR US** Fractious in the barriers and reared on a number of occasions.

Trainer J Bazan was advised that a warning would be placed on

the gelding in relation to its barrier manners.

**3 NEED A GIGGLE** Was slow to begin.

**6 DON TURBOAS** Was inclined to lay in under pressure in the early stages of the

home straight.

**7 LE COSTA PARADISO** Was fractious in the barriers.

**9 GRAND DESTINY** Near the 1200 metres, when inclined to race fiercely, had to be

steadied away from the heels of FIERCE 'N' FABULOUS which shifted in when not fully clear. After considering all of the circumstances, Jockey A Darmanin was issued with a reprimand for careless riding under the provisions of AR 131(a) and was advised that in similar circumstances he would be expected to be

sufficiently clear of runners when shifting ground.

**10 LITTLE RIVER LASS** Proved difficult to load. Near the 850 metres was momentarily

inconvenienced by LORD HEAR US which, after brushing with INFRINGEMENT, raced ungenerously for a short distance and shifted in. Near the 800 metres was again momentarily

inconvenienced when awkwardly placed on the heels of LORD HEAR US which, after brushing with INFRINGEMENT, shifted

ground.

**13 FIERCE 'N' FABULOUS** Was inclined to lay in over the final 100 metres.

**15 INFRINGEMENT** Slow to muster early speed. .

#### RACE 3 - LADBROKES RACING EXTRAS IN MULTI CLASS 1 HCP - 1400M

**3 PLAYED STRONG** Jumped away awkwardly. Over-raced in the early and middle stages.

**4 SOUTH GEORGIA** Raced wide without cover in the early stages.

**5 WANNABE ZIGGY** Near the 250 metres was momentarily inconvenienced by SOUTH

GEORGIA which shifted in under pressure before being corrected by

its rider.

**8 GAZZA'S SPIRIT** Raced wide without cover throughout.

#### RACE 4 - LADBROKES MEGA MULTI BM60 HANDICAP - 1400M

**3 FIORENTE DE LEGEND** Rider requested to view the print of the photo finish.

**5 IFFYCOULD** Was inclined to over-race during the early and middle stages and

near the 1200 metres had to be eased away from the heels of GEORGARONI which shifted in when not fully clear. Jockey D Pires, the rider of GEORGARONI, will be advised to exercise more

care in similar circumstances in future.

**7 STEELE MY SUNSHINE** The start was delayed when the mare was declared a late

scratching at 2.21pm by the order of Stewards when Jockey C Van Munster was declared unfit to ride by the Medical Staff after sustaining a mild concussion in the barriers when STEEL MY SUNSHINE became fractious. Trainer J Luttrell was advised that the mare will not be permitted to race until it barrier trials to the

satisfaction of the Stewards on one occasion.

Jockey C Van Munster, who suffered a mild concussion, was stood down from riding for a minimum of 12 days under the Tasracing Concussion Policy, in which a medical clearance must also be

submitted prior to riding again.

Correct weight was delayed for Jockey E Byrne Burke, the rider of FIORENTE DE LEGEND which was placed second to view the official Judges print. After viewing the official print E Byrne Burke was satisfied with the Judges placings and correct weight was declared.

#### RACE 5 - WINNING EDGE PRESENTATIONS BENCHMARK 60 HANDICAP - 2100M

**7 STRATOJACK** Was inclined to over-race during the early stages. When guestioned

on the performance today Apprentice J Johnstone stated the gelding failed to respond to his riding and got too far back in the early stages. When he attempted to improve approaching the home turn there was little response until the concluding stages.

**8 WILLINGLY** Reared as the start was affected and lost ground.

**10 SIR JAG** Raced wide without cover in the early stages.

#### RACE 6 – KEVIN SHARKIE BENCHMARK 68 HANDICAP - 1400M

**3 DANTES**Momentarily raced in restricted room on jumping away between

CAPTAIN Cam and KAKIA both of which shifted ground.

**7 STARDARMUS** Slow to begin.

#### **RACE 7 – WIZENBERG HANDICAP – 1100M**

**1 GEEGEES GEMSTONE** Bumped with TSUNAMI SAM on jumping away. Jockey A Darmanin

was issued a reprimand under ARR 131(b) for failing to ride his mount out to the finish. In determining not to issue a more severe penalty, the Stewards were satisfied that it had no bearing on the placings.

**2 TSUNAMI SAM** Bumped with GEEGEES GEMSTONE on jumping away.

**4 PERSPIRATION** Approaching the 600 metres bumped with IN THE OCEAN on a

number of occasions.

**6 ZEWINNA** Bumped with TSUNAMI SAM on jumping.

**7 IN THE OCEAN** Raced wide without cover throughout. Approaching the 600 metres

bumped with PERSPIRATION on a number of occasions. A post-race veterinary examination revealed a high heart rate and slow recovery

which required veterinary treatment.

#### RACE 8 - MINGARI + CO CLASS 4 HCP- 1200M

**1 JEHBENTI** A post-race veterinary examination revealed the gelding to have

bled from both nostrils. Trainer J Bazan was advised the gelding will be stood down under AR79(4)(b); the gelding must not be trained on an official racetrack, private establishment, or any other place for a period of two (2) months, then must not start in an official race for a period of three (3) months, and only after a satisfactory 1000 metre gallop in the presence of stewards.

**7 ESPRIT DIVA** Was tightened for room on jumping away between JEHBENTI and

ARAYA SUNSHINE both of which shifted ground. When the pace of

the race eased near the 600 metres, when caught wide was

allowed to stride forward and take up the lead.

**9 SPEED ROCK** Had a tendency to lay out in the home straight and as a result was

unable to be ridden out fully.

**11 GLOBAL AWARENESS** Was inclined to over-race during the early and middle stages.
