#### RACE 1 – LADBROKES BIG BETS PACE – 1609M MS

A warning placed on JUST LIKA DREAM (J. Herbertson) which hung inwards despite efforts of the driver and raced inside marker pegs on home turn final occasion.

A post-race veterinary examination of RAGING ON (K. Gath) which was beaten 205 Metres revealed no abnormalities. Trainer W. Yole advised gelding stood down until completes a satisfactory trial.
