Trainers with multiple runners in a race advised Stewards of intended tactics.

RACE 1 – TASSIE WASTE SERVICES PACE – 2180M SS

GOBSMACKED (H. Van Dongen) which galloped from barrier continue to be out of the draw.

ONLINE MODEL (J. Chibnall) which led the race gave ground over final 450 Metres to be beaten 43 Metres.

RACE 2 – 2026 NEW YEAR NEW VIBES PACE – 2180M MS

BARBETTE (D. Ford) underwent veterinary examination at barrier and passed fit to start.

Warnings placed on CAPTAIN CHEDDAR (L. Older) and ROLLWITHARTY (K. Williams) which galloped leaving back straight after start.

Warning placed on PIROTIC (T. Rattray) which galloped near 200 Metres and Shin and Tendon boot became detached whilst in a break.

RACE 3 – LET ME PLAN IT PACE – 2180M MS

WHAT A WOMAN (G. Rattray) which galloped on three occasions stood down until completes a satisfactory trial.

Warning placed on ALBY PRIDDY (M. Jones) which galloped in back straight final occasion checking MONTGOMERY LOMBO (T. Rattray).

Warning placed on VINCENTS RAINBOW (D. Ford) which galloped home straight run to finish. Stewards did not take any further action as had not gained ground.

RACE 4 – KEVIN REDPATH NORTH WEST PLATE FINAL – 2180M SS

A False start called when 10 Metre tape failed to clear the horses.

SAPPHIRE GAMBLER (J. Duggan) inside marker peg home turn final occasion.

RACE 5 – LADBROKES BLACKBOOK PACE – 2180M SS

All clear delayed to allow B. Davis 9MAJOR DAVVIN) placed 4th to view photo print. After viewing the print all clear was given.

Reins person C. Castles (TULLAH GIRL) questioned the process of the start in that he felt that his horse should have been leading the horses to the barrier. Stewards informed him that the outside horses lead the line to always face the barrier.

Starter Mr. Bauld was advised by Stewards that he should have had the field closer to the barriers than what had occurred in this start.

RACE 6 – LADBROKES RACING EXTRAS IN MULTI PACE – 2180M MS

In the home straight after warm down lap MY ULTIMATE JACKO (G Rattray) fell to the track and after being attended to by the veterinary officer it was found to be deceased. In the opinion of the veterinary officer, it had suffered a heart attack. Postmortem samples were taken for analysis.

Reins person G. Rattray said the horse had travelled reasonably in the run and could offer no other explanation. Trainer Wayne Yole stated that leading into this race the Rig had worked satisfactorily and had no signs of any problems.

RACE 7 – ROD GLOVER LEGAL PACE – 1892M SS

Leaving front straight after start GOTAHAVEAHOBbie (L. Older) hung inwards when it had MACH ANGELO (H. Van Dongen) racing to its outside and as a result CHRIS BE QUICK (B. Davis) which had been making ground on the pegs contacted sulky of Older and raced roughly. CHRIS BE QUICK was then retied from race shortly after as it had broken a back hopple carrying strap.

RACE 8 – BURNIE PLUMBING SUPPLIES PACE – 2180M MS
