A post-race veterinary examination of ASTON TERESA revealed the greyhound to have no abnormalities. In the opinion of the Stewards this greyhound failed to pursue the lure pursuant to GAR 124 turning off the back straight. Pursuant to GAR 127(a) it has been suspended from competing at Hobart only for 28 days and until the completion of a satisfactory trial.

*General:*

INHERITED CHARM completed a satisfactory 6-month trial over 340 metres. Beginning from box 5 weighing 35.5 kg, the greyhound finished the trial in 19.17 seconds and has been cleared to race at all tracks.

ZARI EXACT completed a satisfactory trial for Failing to Pursue due to injury over 461 metres. Beginning from box 3 weighing 32.7 kg with two other greyhounds, the greyhound finished third in 26.47 seconds and has been cleared to race at all tracks except Ballarat.

GRAPEFRUIT EXPEL completed a satisfactory trial for Marring over 461 metres. Beginning from box 5 weighing 27.8 kg with two other greyhounds, the greyhound finished first in 26.27 seconds and has been cleared to race at all tracks except The Meadows.

REINDEER HEGHOG completed a satisfactory trial for Marring over 461 metres. Beginning from box 7 weighing 33.1 kg with two other greyhounds, the greyhound finished second in 26.34 seconds and has been cleared to race at all tracks except Ballarat.
