### RACE 1 – PETER WILSON MEMORIAL – 1810M SS

THE VIXEN – Began badly and will be out of the draw in future standing starts events

ASHANTE QUEEN – Began badly and was placed on its last chance in the draw. Checked and raced roughly at the 400m

RUBINS PLIGHT – Was severely checked at the start when Ashante Queen began badly. Trailed the field. A post-race vet examination revealed no abnormalities

STREET APPEAL – Broke in running on two separate occasions. Will be required to perform a satisfactory trial before racing again.

General – Stewards inquired into the reasons for ASHANTE QUEEN being checked and racing roughly at the 400m. After speaking with drivers Dylan Ford(Just Follow Me), Jacob Duggan(Kenya) and Jordan Chibnall(Ashante Queen) and viewing the patrol footage, stewards could not attribute the incident to any one driver, therefore no further action was taken.

### RACE 2 – HARRIS FUNERALS ST HELENS – 1810M SS

GOODTIME OSCAR – Began badly and placed on its last chance in the draw

DREAM MELODY – Raced roughly after the start

ONLINE MODEL – Began badly and placed on its last chance in the draw

DONE WELL – Galloped out

### RACE 3 – 6TY COUNTRY GUINEAS – 1810M SS

SPORTY GRANT – Galloped out

BETTERTHANPRETTY – Began badly and placed on its last chance in the draw

SHEZALLLOLLIES – Broke and fell. Stood down until the completion of a satisfactory trial. A post-race vet examination revealed no abnormalities

NIKITA JO – Began badly and placed out of the draw in future standing start events

CAPTAIN CHEDDER – Stood flat footed at the start and lost considerable ground – placed on its last chance in the draw. Gave ground over the concluding stages

FEELINKINDALUCKY – Began badly and placed on its last chance in the draw

OBLER – Raced roughly after the start.

General – Driver Brodie Davis was checked by the medical professionals following the fall. No significant injuries were found and he was passed fit to fulfill the rest of his engagements

### RACE 4 – SKA POWER AND CONTROL – 1810M SS

CINOCAL JAMANE – Began badly and placed out of the draw in future standing start events

TOP HANOVER – Inconvenienced after the start by Cinocal Jamane

GOTTAHAVEAHOBIE – Galloped out. Gave ground over concluding stages and placed on its last chance to race competitively. A post-race vet examination revealed no abnormalities

SANJE COLLINS – Gave ground and was placed on its last chance to race competitively

### **RACE 5 – ST MARYS CUP – 2400M SS**

WAZZA – Hung out under pressure from the 500m to the home turn. A warning was placed on the horse's racing manners

MY WAY – Began badly and placed on its last chance in the draw

IDEN LADY LINCOLN – Began badly and continues to be out of the draw in standing start events

ROCKANDAHARDPLACE – Held up in the concluding stages.

General – Stewards spoke to driver Dylan Ford regarding the incident at the 500m when Wazza left the pegline and The Chancer was able to obtain a run to his inside. After viewing the patrol footage and acting on their own observations, stewards deemed the incident to be a result of Wazza hanging under pressure. A warning was subsequently placed against the horse's racing manners

### **RACE 6 – DON AND CAROLE WOODS MEMORIAL – 1810M SS**

CAMBRO FLASH – Began badly and will be placed outside the draw in future standing start events. The gelding then galloped for approximately 500m which was deemed to be excessive. A satisfactory trial will be required before racing again.

JILLIBY JAY SEA – Began badly and placed on its last chance in the draw

ARMA ROLLING STONE – Began badly and placed on its last chance in the draw

PERFECT CUT – Began badly and placed on its last chance in the draw. Gave ground from the 400m and placed on its last chance to race competitively

NO NUKES SKIPPER – Held up for clear running.
