### Comments / Explanations:

#### RACE 1 – 1:18PM – LADBROKE IT! MAIDEN/CLASS– 1880 METRES

##### **2 DANTES (NZ)**

Tended to over race at various stages.

##### **5 FIORENTE DE LEGEND**

Stewards reminded jockey B Muchu of his obligations regarding the height of his whip use. ARR 132(6)(b).

#### RACE 2 – 1:53PM – DR “THE DOC” LESLIE SENDER MAIDEN - 1150 METRES

##### **6 RICHARDS**

A post-race veterinary failed to reveal any abnormalities. Trainer T Evans indicated to stewards the gelding would now be retired.

<b>9 BELLA CHINKARA</b>	Tended to lay in under pressure during the run to the finish.
<b>10 GLOBAL MIRACLE</b>	Stewards issued rider S Ingelse a severe reprimand under AR131(a), in that she shifted in when insufficiently clear of RICHARDS who had to be steadied.

### **RACE 3 – 2:28PM – G.A. “JOE” MASON MEMORIAL MAIDEN - 1350 METRES**

<b>1 DEEPER WATER</b>	Raced three wide throughout.
<b>4 NORHTERN CHILD</b>	Shifted out on straightening, hampering the run of VORTISTAR.
<b>5 SAVAGE RIVER</b>	Tended to over-race in the early stages.
<b>8 CHEEKY TILLY</b>	Slow to jump and muster early speed. Tended to over-race in the early stages. Shifted out over the heels of MISS MABEL near the 200m.
<b>9 WHITE STAR SUZIE</b>	Tended to over-race in various stages.
<b>12 GRAPHITE POWER</b>	Shifted in, when under pressure tightening the run of MISS MABEL. Rider K Boxall reported the filly raced greenly throughout.
<b>15e MISS MABEL</b>	Severely checked and contacted at about the 200m by GRAPHITE POWER, which had shifted in. A post-race veterinary examination revealed no significant finding.

Stewards inquired into an incident near the 200m, in where MISS MABEL (L Annells) was severely checked by GRAPHITE POWER (K Boxall). In assessing all evidence, Stewards ascertained GRAPHITE POWER had shifted in, when placed under pressure, and in turn had taken MISS MABEL in towards the running rail, ultimately tightening and contacting that horse's shoulder, before the filly was severely checked and lost her rightful running. Rider Boxall pleaded guilty of a charge under AR131(a), Careless Riding, and subsequently her license to ride in races was suspended for a period of two (2) Tasmanian race dates. In assessing penalty Stewards took into account plea of, previous record and high degree of interference.

### **RACE 4 – 3:03PM – RJ (SNOW) & NK AYLETT MEMORIAL CLASS 4 - 1350 METRES**

<b>4 WYNDINTHEWILLOWS (NZ)</b>	Tended to hang in at various stages.
<b>5 PLAYED STRONG</b>	Bounded on jumping.

**7 CRYSTAL MOONBEAM**

Re-saddled behind the barriers.

**9 STAR FORTIAN**

Jumped outwards at the start. Hampered near the 200m, by the tiring CRYSTAL MOONBEAM.

**10 WHISPER OF MATILDA**

Slow to jump.

**12 GIE IT LALDY**

Stewards granted permission for D Pires to ride 1 kg over the allotted minimum weight. Rider D Pires reported when attempting to ride out over the concluding stages, he had felt as though the mare began to wobble, and as such had stopped riding.

A post-race veterinary examination revealed no significant findings.

Trainer R Hall was reminded of her obligations when ensuring her horses are presented to race with correctly fitted saddles.

**RACE 5 – 3:40PM – AJ & NM SKIRVING MEMORIAL BM60 HCP - 1350 METRES****3 GEMS EAGLE**

Fractious in the barriers prior to the start. Rider C Wells reported the gelding failed to respond to her riding over the concluding stages. A post-race veterinary examination revealed no significant findings.

Trainer D Tyson was questioned in relation to his colors being used on GLOBAL AWARENESS. Trainer Tyson advised that he was in the process of obtaining a share in the horse. Stewards advised that until a transfer has been registered, his colors should not be used on any horse not in his trainership, or ownership.

**RACE 6 – 4:20PM – LADBROKES CUP PUNTERS MARQUEE BM76 HCP – 1009 METRES****1 CAPTAIN CAM**

Reared in the barriers prior to the start. Tended to over-race in various stages. Stewards spoke with Rider L Burke in regard to the racing manners of CAPTAIN CAM in the early stages. Rider Burke reported that she had been attempting to restrain her mount at the time when MAKE A DECISION (J Johnstone) had pushed up to the inside of CRUZ MISSILE (S Ingelse) ahead of her, which in turn had caused her horse to begin to over race. She further stated that she had not felt restricted for room at any stage. Stewards noted the circumstances.

Slow to muster early speed.
