RACE 1 – TYPEFACE PACE – 2090M MS

No racing incidents

RAC 2 -- FEHLBERGS PRODUCE SPRINTLANE PACE – 1609M MS

SHEZ ALL HEART (J. Watson) which galloped leaving back straight first occasion and raced roughly entering back straight final occasion stood down until completes a satisfactory trial.

EVERYTHING BUT THE (E. Arnott) which had been held up for clear running after taking a tight run approaching finish paced roughly.

LUVATINNY (C. Crook) utilized sprint lane to win the race.

RACE 3 – GROUP 1 TASMANIA CUP 28TH FEBRUARY PACE – 2090M MS

Near 400 Metres SHOOBEES SPIRIT (J. Watson) checked and broke when IDEN LADY LINCOLN (T. Ford) commenced to give ground. Trainer T. Langley advised a warning placed on IDEN LADY LINCOLN which was beaten 83 Metres.

RACE 4 – LATHER UP @ WOODLANDS STUD PACE – 1609M MS

Stewards cautioned M. Jones (SINISTER) for not correcting his drive when it shifted up the track over concluding stages. R 162 (www)>

Race 5 – LABROKES BIG BETS PACE – 1609M MS

Near the 300 Metres SUE NIEN (J. Duggan) hung inwards and locked sulkies with COOLANDCOLLECT (R. Duggan) which checked ALWAYS AURORA (D. Ford) who contacted marker pegs. A post-race veterinary examination of SUE NIEN revealed a slightly elevated heart rate.

RACE 6 – DOWNBYTHESEASIDE @ WOODLANDS STUD PACE – 1609M MS

OH NO NEVER AGAIN (J. Watson) hung inwards and contacted marker peg near 800 Metres.

MIDNIGHT DANCER (C. Crook) hung inwards approaching home turn final occasion contacting marker pegs.

SHALLOW BEACH (D. Ford) paced roughly over concluding stages. The right foot of D. Ford momentarily came out of footrest near Metres.

RACE 7 – TASMANIAN HORSE TRANSPORT PACE – 2090M MS

Approaching finish of race KIAVINO STRIDE (H. Van Dongen), which was giving ground tightened for room when JILLIBY JAY SEA (D. Ford) shifted up the track and at that point ROLLWITHARTY (R. Duggan) was racing to her outside. Stewards reminded Ford of his obligations.

DAZZLE ME (L. Older) held up for clear run early stages home straight and when clear ran to line strongly.

ANGELSHAVTIME (M. Yole) utilized sprint lane to win race.
