### RACE 1 – LADBROKES BIG BETS PACE – 2180M SS

GOODTIME OSCAR (D. Ford) galloped away but lost no ground.

CAN FEEL THE FURY (L. Older) slow to begin.

### RACE 2 – IMPRESS PRINT PACE – 2180M MS

MIKIYOURSOFINE (H. Van Dongen) raced roughly at the start. Approaching winning post at finish of race tightened for room by HEY FRANCO (D. Ford) and DAZZLE ME (L. Older) both of whom shifted ground. Stewards reminded Ford and Older to exercise more care.

TAKING A PUNT (M. Yole) which galloped in front straight first occasion placed on last chance to race truly.

### **RACE 3 – ANNE RAWLINGS THORATE MEMORIAL – 2180M MS**

ALBY PRIDDY (K. Williams) which galloped shortly after start will be excluded from draw in mobile barrier start races.

A warning placed on MY FATAL CHARM (L. Older) hung in on home turn first occasion and checked FANCY ANOTHER (B. Davis). MY FATAL CHARM again hung inwards leaving front straight final occasion and the held up for clear run until Older forced HAMMERING SEAS (D. Ford) up the track near 75 Metres. Stewards issued Older with a reprimand for manner in which he shifted ground. R 163 (1) (a) (iii).

A warning placed on FANCY ANOTHER which galloped approaching home turn final occasion.
