Trainers with multiple runners in a race advised Stewards of intended tactics.

RACE 1 – LADBROKES BIG BETS PACE - 1670M MS

I GOTTA GO (R. Ashwood) inclined to shift ground up track over concluding stages allowing an inside run to WEE GEORGIE WOOD (K. Kendall).

RAC 2 – REBECCA WHITE STAKES - 2150M MS

A post- race veterinary examination of CANNON BEACH (M. Yole) revealed it had bled from nostril. Trainer W. Yole advised gelding stood down until completes a satisfactory trial. R 101B (2).

RACE 3 – BARUNAH STOCK FEED PACE – 2150M MS

Stewards spoke to Jacob Duggan (SUE NIEN) regarding his actions approaching home turn final occasion when SIR NIPPA (C. Crook) was contacting his body. Stewards were satisfied that there were extenuating circumstances with Duggan's drive giving ground and SIR NIPPA held up and travelling strongly.

RACE 4 – BENDIGO BANK DELORAINÉ & DISTRICT PACE - 1670M MS

LOYOLA LILLY, Trainer K. Pratten underwent a pre-race veterinary examination and passed fit to start.

MY BEAUTIFUL LIFE (K. Kendall) which galloped on two occasions free of interference stood down until completes a satisfactory trial. Stewards reminded K. Kendall that when her drives are in a break at earliest opportunity move them inside the marker pegs.

RACE 5 – WESTWOOD QUARRY TRAINERS INCENTIVE HEATN HEAT ONE - 2150M MS

Stewards considered a protest lodged by Tiarna Ford (SWEET PIXIE) 2ND against MCHAYEM (R. Hillier) alleging interference home straight concluding stages. After taking evidence from both drivers, viewing film and acting upon their observations Stewards dismissed the objection as they were of the opinion SWEET DIXIE had been hindered the margin of 3.5 Metres did not justify altering placings. Stewards subsequently fined R. Hillier \$100 for not correcting his drive when it shifted ground. R 162 (1) (www) (a).

A false start called when EVERYTHING BUT THE (R. Ashwood) galloped approaching start when its bridle caught in the mobile barrier. Upon reviewing film of the incident and hearing evidence from R. Ashwood that he had been unable to restrain his drive as JADEZ (T. Rattray) was continually contacting his helmet and he was unable to check his drive.

Reins person (T. Ford) fined \$100 for using whip in more than flicking motion R 156 (2) (a).

A warning placed on MUZZAME MATE (K. Kendall) which hung inwards and contacted sulky of SWEET DIXIE entering back straight first occasion.

Sulky tyre on GLENVIEW LANIKAI (L. OLDER) deflated near 200 Metres.

RACE 6 – BARASTOV RACE N WIN PACE - 1670M MS

Field turned away from barrier in score up when tongue tie on ENJOY LIFE (M. Yole) became detached.

ENJOY LIFE which was out of position despite efforts of driver excluded from draw in mobile barrier start races.

Stewards advised starter Mr. D. Bauld that as ENJOY LIFE was out of position and inconvenienced DANCINGWIVJOLENE (K. Kendall) in future he abort the start.

ANGEL ROCKS (D. Ford) held up for clear running home straight final occasion.

RACE 7 – WESTWOOD QUARRY TRAINERS INCENTIVE HEAT TWO - 2150M MS

CAMBRO FLASH (J. Walters) which galloped after start checking GUENEVERES MADONNA (C. Castles) will be excluded from draw mobile barrier start races.

Reins person L. Older (FRANCO VAI) fined \$100 for contacting and puncturing offside sulky tyre of JUDYSMEMUM (G. Rattray) near 400 Metres. R 168 (1) (a).

RACE 8 – HALWES FREE FOR ALL PACE - 1670M MS

MAGNETIC TERROR (G. Rattray) which galloped at start excluded from draw in mobile start races.

RACE 9 – TAS SEED, DRESSING & STORAGE STAKES - 2150M MS

LOYOLA TRIOS, Trainer K. Pratten underwent a pre-race veterinary examination and passed fit to start.

A false start called when OBLER (E. Arnott) galloped in score up checking runners on second line. OBLER excluded from draw in mobile barrier start races.

A warning placed on LOYOLA TRIOS (K. Pratten) which hung inwards and dislodged two marker pegs on home turn final occasion.

RACE 10 – HAMMONDS SEAFOOD STAKES – 2150M MS

No racing incidents.

RACE 11 – TASMANIAN HEAVY HAULAGE PACE – 1670M MS

HARBOUR SPRINGS (J. Duggan) which galloped leaving back straight first occasion severely checking NORBET (J. Walters) placed on last chance to race truly.

LALIBELA (H. Van Dongen) retired from race when near front hopple carrying strap broke. Gear inspected and found to be of average quality and Trainer W. Yole advised accordingly.
