### Comments / Explanations:

#### RACE 1 – AVISO TAS INSURANCE BROKERS CLASS 4 – 1200 METRES

<b>1 GEE GEES ME BOY</b>	Raced three wide throughout.
<b>2 HURRICANE KETUT</b>	Slow into stride.
<b><del>4 NAVARRE RIVER</del></b>	SCRATCHED
<b>5 LADY GALADRIEL</b>	Fractious in the barriers.

General – Stewards questioned apprentice J Johnstone regarding the performance of MASTRETTA. He stated that the horse travelled well in the run but was disappointing when placed under pressure in the home straight. A post-race vet examination revealed no abnormalities. Apprentice Johnstone pleaded guilty to a charge under ARR218(4) for possessing a mobile phone in the jockeys room. He was subsequently fined \$200.

### **RACE 2 – LADBROKES BIG BETS BM68 HANDICAP – 1100 METRES**

<b>1 QUICKEN UP</b>	Compounded from the 200m. A post-race veterinary examination revealed no abnormalities.
<del><b>2 MAKE A DECISION</b></del>	SCRATCHED
<b>5 GOLDEN MEADOW</b>	Had to be steadied off the heels of QUICKEN UP at the 1000m

Stewards spoke to apprentice Shayleigh Ingelsie (QUICKEN UP) and advised her to exercise more care when shifting ground when GOLDEN MEADOW had to be steadied when she crossed near the 1000 metres when not fully clear.

### **RACE 3 – KEVIN SHARKIE MAIDEN – 1200 METRES**

<b>8 STRATO KEN</b>	Travelled wide throughout
<del><b>9 DUBAI AFFAIR</b></del>	SCRATCHED
<b>10 WHEELWE</b>	Travelled wide throughout
<b>12 HIGHLAND CRYSTAL</b>	Hung out from the 600m and consequently had to be steadied away from the heels of Strato Ken.
<del><b>13 LIGHT WORK</b></del>	SCRATCHED
<b>14 UP TO TORI</b>	Held up for clear running nearing the 250m
<del><b>16 VANSITART</b></del>	SCRATCHED

#### **RACE 4 – OLIVE TREE CATERING BM60 HANDICAP – 1430 METRES**

<b>1 HIGH TAIL EAGLE</b>	Slow to begin. Hung outwards at various stages. Gave ground from the 500m. A post-race vet examination of HIGH TAIL EAGLE revealed no abnormalities.
<b>2 BERSERKER</b>	Held up for clear running from the home until passing the 200m.
<b>3 BLOOMTIME</b>	Reared on jumping.
<b>5 ETHICAL DILEMMA</b>	Travelled wide throughout.
<b>6 I'M CHEV</b>	Disappointed for a run passing the 200m and held up for clear running thereafter.
<b>8 SANDUAL</b>	Over-raced in the middle stages.

#### **RACE 5 – KEVIN SHARKIE ELWICK STAKES – 1100 METRES**

<b>1 ARISTOPOLOS</b>	Travelled wide throughout. Laid out under pressure in the home straight.
<b><del>3 BRUTAL EMPIRE</del></b>	SCRATCHED
<b>5 TSUYOI KITSUNE</b>	Slowly away.
<b>7 TOO POETIC</b>	Held up for clear running in the home straight
<b>8 OLINDAH</b>	Raced keenly in the middle stages. Laid in under pressure in the home straight.
<b>9 PRECIOUS ILLUSION</b>	Laid in shortly after straightening.

#### **RACE 6 – LADBROKES MEGA MULTI C1 HANDICAP – 1200 METRES**

<b>1 ILOVETHISTOWN</b>	Travelled wide throughout.
<b>4 OLIVE GIRL</b>	Held up for clear running rounding the home turn.
<b>5 PIPING WILLOW</b>	Fractious in the barriers and then slow to begin. Steadied. away from the heels of Olive Girl approaching the home turn.

<b>6 SOUTHERN AURORAS</b>	Held up for clear running from the home turn until the 200m.
<b>10 BELLA CHINKARA</b>	Steadied off heels at the 250m and then shifted wider to obtain clear running.
<b>11 REDAIR</b>	E Byrne-Burke(Redair) pleaded guilty to a charge under AR132(7)(a)(ii) for using the whip more than 5 times (9 times)prior to the 100 metres. After taking submissions on penalty she was fined the sum of \$400.

#### **RACE 7 – WINNING EDGE PRESENTATIONS THOUSAND GUINEAS – 1600 METRES**

<b>2 BRIGHT NIGHT</b>	Held up for clear running until the 200m
<b>3 JENNI THE CAT</b>	Over-raced in the early stages. Held up for clear racing room approaching the home turn
<b>8 LITTLE EL</b>	Stewards queried improved performance

General – Stewards questioned stable representative Clinton Gaffney regarding the improved performance of LITTLE EL. Mr Gaffney explained that the filly was very unlucky last start and in his opinion, should have won. He further explained that the filly was suited to stepping up in distance, and considered that the filly would be competitive in against this field.

#### **RACE 8 – MINGIRL + CO HANDICAP – 1600 METRES**

<b>2 TASSIE POWER</b>	Steadied off the heels of STRATOJACK passing the 200m.
<b>3 FRENCH SOUL</b>	Gave ground from the 600m
<b>4 MANHATTAN NIGHTS</b>	Steadied off the heels of TASSIE POWER at the 200m and then shifted wider to obtain clear running.
<b>7 SKY EAGLE</b>	Steadied off the heels of Tassie Power passing the 200m
<b>9 VALIANT KHAN</b>	Steadied off the heels of Stratojack passing the 200m
<del><b>10 GAZZA'S SPIRIT</b></del>	SCRATCHED

Stewards inquired into an incident passing the 200m when STRATOJACK (Codi Jordan) shifted inwards to obtain clear running and VALIANT KHAN (Chloe Wells) and TASSIE POWER (Erica Byrne Burke) were tightened for racing room and had to be steadied. After viewing the patrol footage and acting on their own observations Ms Jordan was issued a severe reprimand under rule AR131(a) for shifting in when insufficiently clear.

A post-race vet examination of FRENCH SOUL revealed a number of loose caps on the incisors and a slow recovery.

A post-race vet examination of VALIANT KHAN revealed a high heart rate and a slow recovery.

### General

#### *TTC Race 1 23/01/2026 Adjourned Inquiry.*

Apprentice C Wells pleaded guilty to a charge under AR 131(a) for Careless Riding for allowing her mount CRUZ MISSILE to shift in at the 650 metres when not clear of WHIPPIN PICCADILLY which was checked and lost its position. After taking submissions on penalty including her good record and the mid-range level of the careless and interference her licence to ride in races was suspended for 1 Tasmanian race date. This will commence at Midnight 30/1/2026 and expire Midnight 6/02/2026.

#### *TTC 23/01/2026 Race 8 Adjourned Inquiry.*

Stewards inquired into reasons for MIGHTY MAXI having to be restrained approaching the finish. It was established that ROYAL DISPATCH (K Lane) had shifted in when not fully clear and at the same time CHICANE had shifted out to place MIGHTY MAXI in restricted room. Stewards did not deem one rider fully culpable for the interference but advised riders to take more care when their mounts shift ground.
