Trainers with multiple runners in a race advised Stewards of intended tactics.

RACE 1 – MAXFIELD PACE - 2200M MS

Reins person M. Yole (ENJOY LIFE) fined \$100 for using whip in more than flicking motion.
R 156 (2) (a).

A warning placed on ENJOY LIFE which shifted ground up track in run to finish and hindered LOUGLE (C. Crook).

Stewards reprimanded J. Walters (BLAZING TART) for tightening ground of POST KEG (T. Rattray) leaving front straight first occasion. R163 (1) (a) (iii)

RAC 2 – HARDINGS GROUP PACE - 1680M MS

A warning placed on JUST LIKA DREAM (T. Rattray) which hung outwards and galloped in back straight final occasion.

RACE 3 – COLLINS HOMES PACE – 1680M MS

A warning placed on TALK IS CHEAP (L. Older) for out of position at start.

RACE 4 – JEREMY ROCKLIFF MP COASTAL PACING THOUSAND - 2200M MS

A post-race veterinary examination of AMBIGUOUS (C. Castles) confirmed it had suffered a bleeding attack. Trainer C. Crook advised gelding is stood down for life as this was its second bleeding attack. R 101 (3) (b).

RACE 5 – LADBROKES DASH FOR CASH - 1680M MS

The reins person licence of J. Watson (RAKADAN) was suspended for 10 days after he had pleaded guilty to a charge of careless driving in back straight final occasion as he allowed his drive to crowd racing room of CELEBRITY ROYAL (M. Yole) who forced ANOTHER NIEN (J. Duggan) onto marker pegs. R 163 (1) (a) (i). In assessing penalty plea of guilty, driving record and degree of interference considered.

A post-race veterinary examination of JAMES CAGNEY (T. Ford) which was beaten 79 Metres revealed no abnormalities.

RACE 6 – ULVERSONE CYCLES PACE - 2200M MS

A warning placed on DAZZLE ME (L. Older) out of position at start.

The right foot of G. Rattray (FAMILY REASONS) momentarily slipped from footrest approaching winning post at finish of race.

RACE 7 – HORSES N MORE DEVONPORT CUP - 2698M SS

Warning placed on THE SHALLOWS (B. Davis) which commenced poorly.

Warning placed on KEAYANG FITZY (M. Yole) a which galloped out.

MAGNETIC TERROR (R. Hillier) galloped at start and will continue to be out of the draw.

RACE 8 – TASFRIEGHT PACE - 1680M MS

A warning placed on CAMBRO FLASH (J. Walters) which galloped leaving back straight first occasion. Trainer C. Miller advised Stewards he would have the gelding undergo a veterinary examination prior to starting in a race

Reins person L. Older (OUR WILLOW) reported the mare may have choked. A post-race veterinary examination of OUR WILLOW (L. Older) revealed increased upper respiratory noise and Trainer informed veterinary clearance required.

RACE 9 – LADBROKES MARES INCENTIVE - 2200M MS

A post-race veterinary of CAN DO MAGIC (C. Castles) which was beaten 150 Metres revealed no abnormalities. Trainer D. Spring advised mare stood down until it can trial competitively.

RACE 10 – S & M HORSE TRANSPORT PACE - 1680M MS

No racing incidents.
