A post-race veterinary examination of MORDEN revealed the greyhound to have a right tensor fascia muscle injury, requiring a fourteen (14) day stand down period.

Stewards spoke with Trainer E Medhurst regarding the action of MORDEN in the home straight, in particular, where the greyhound appeared to turn its head and make head and muzzle contact with the runner to its inside (ZIPPING PORTIER).

Pursuant to GAR 126, Stewards found the greyhound guilty of marring, despite noting the greyhound's injury. As this was the greyhound's second offence under GAR 123, MORDEN has been stood down from racing at all tracks for a period of 28 days, and until completion of a satisfactory trial.

A post-race veterinary examination of CAYMAN DANGER revealed no abnormalities.
