Trainers with multiple runners in a race advised Stewards of intended tactics.

RACE 1 – LADBROKES HOSTED POTS PACE - 2200M MS

A false start called REID GRANT (M. Yole) galloped approaching the start and checked runners on second line. Trainer S. Woods advised gelding excluded from draw in mobile start races.

Stewards reprimanded B. Davis (KING BART) for way he used whip over concluding stages of race R 156 (2) (a). He was also advised to refrain from allowing his body to be outside confines of sulky. R 170 (2)

RAC 2 – LADBROKES BIG BETS COPY NOW PACE - 2200M MS

No racing incidents.

RACE 3 – BEVAN LEE'S BUTCHERY PACE - 1680M MS

A warning placed on HEY MIKI (Grace Jones) who was out of position at start despite efforts of driver.

A post-race veterinary examination of BUSLOAD OF FAITH (G. Rattray) which pulled hard in running and was beaten 174 Metres revealed no abnormalities. Trainer W. Yole advised gelding is stood down until completes satisfactory trial.

RACE 4 – IMPRESS PRINT STAKES - 2200M MS

In back straight first occasion PORT RUN MACHINE (G. Rattray) was inconvenienced as it attempted to improve three wide when LOUGLE (C. Crook) who was leading one out line shifted up the track. Stewards reminded Crook to be aware when his drives shift ground, he takes positive action to avoid hindering another runner. R 162 (1) (www) (ii).

A post-race veterinary examination of BARBETTE (M. Yole) at request of the driver which was beaten 52 Metres revealed no abnormalities.

RACE 5 – LADBROKES MEGA MULTI STAKES - 1680M MS

The reins persons licence of H. Van Dongen (QUEENOFDANCE) was suspended for seven (7) days after pleading guilty to a charge of careless driving for when crossing compelling (D. Ford) PARK LANE and DANCINGWIVJOLENE (C. Castles) to check their drives leaving back straight after the start. R 163 (1) (a) (i). In assessing penalty Stewards considered plea of guilty and previous driving record.

The reins persons licence of C. Crook (FIVE STAR SHARK) suspended for fourteen (14) days after he pleaded guilty to a charge of careless driving for attempting to hold his position in an unrealistic manner after being eased wider by DANCINGWIVJOLENE (C. Castles). In considering penalty plea of guilt, previous driving record and the high degree of interference.

Post race veterinary examination of FIVE STAR SHARK revealed laceration to near fore coronary band for which it was treated. Stood down 14 days on veterinary advice.

Post race veterinary examinations of HARRYS DEAL (M. Yole) and LALIBELLA (G. Rattray) revealed minor abrasions only.

MIKI SANZ (Walters) hung in and contacted offside sulky of CINCINNATI (K. Williams) entering home straight final occasion and as result the near side hopple connecting strap broke. A warning placed on MIKI SANZ.

RACE 6 – LADBROKES POPULAR SRM STAKES -1680M MS

No racing incidents.

RACE 7 – THE BOTTLE-O- HADSPEN PACE – 2200M MS

TOLD YOU TWICE (G. Rattray) a late scratching on veterinary advice at 8.43pm due to soreness in off hind foot. Trainer W. Yole) advised gelding stood down until veterinary clearance tendered.

Stewards cautioned M. Yole (KEAYANG FITZY) for not making greater effort to straighten his drive when it shifted ground in run to finish. R 162 (1) (www) (iii).

RACE 8 – VICTORY IMAGES PHOTOGRAPHY PACE - 1680M MS

RAY DAN (D. Ford) which galloped shortly after start excluded from draw mobile start races.

Stewards fine L. Older (MR BONDI) \$100 for advantaging another runner when his drive shifted up the track over concluding stages. R 162 (1) (www) (iii).

RACE 9 – LEES ORCHARD STAKES - 1680M MS

COOLANDCOLLECT (G. Rattray) held up for clear run over concluding stages.
