### *General:*

#### RACE 1 – BARASTOC RACE N WIN PACE – 2150m MS

JILLIBY WORPA – Broke gait racing out of the home straight on the first occasion, and again at the same position after getting the bell. The gelding will be stood down until the completion of a satisfactory trial

PORT RUN MACHINE – Raced roughly from the 400m as the hopple shortener cord had wrapped around the off-side hopple and placed the horse at a disadvantage

REID GRANT – Gave ground from the 600m and placed on its last chance to race competitively.

#### RACE 2 – HARRISON REAL ESTATE STAKES – 2150m MS

General – Driver Liam Older (Dalton Shard) was fined \$200.00 under AHR 156(2)(a) for using an incorrect whip action

### RACE 3 – SADDLEWORLD PACE – 2150m MS

INTO THE HARKNESS – Hung inwards and went inside a marker peg leaving the home straight on the final occasion

DEFENCE ATTORNEY – Inconvenienced behind tiring runners from the 400m-200m. Held up for clear running early in the home straight.

CAN FEEL THE FURY – Inconvenienced when Sir Nippa shifted inwards leaving the home straight on the first occasion

General – Stewards spoke to drivers JORDAN CHIBNALL (Sir Nippa) and LIAM OLDER (Can Feel The Fury) regarding an incident exiting the home straight on the first occasion when Can Feel The Fury was inconvenienced. After hearing the evidence of both drivers and watching the patrol footage, stewards issued a reprimand to Ms Chibnall under AHR163(1)(a)(i)

### RACE 4 – SAVE GREYHOUND RACING IN TASSIE PACE – 1670m MS

Another Nien – Driver Jacob Duggans foot slipped from the rest approximately 25m from the finish. No action taken

### RACE 5 – MAX OLIVER MEMORIAL – 2150m MS

MIKIYOURSOFINE – Severely checked by Lougle on the home turn. The sulkies of both horses became entangled thereafter for approximately 50m

LOUGLE – Broke under pressure approaching the home turn. The horse then shifted up the track and locked sulkies with Mikiyoursofine for approximately 50m. Placed on its last chance to race truly.

LAST OF THE MOHICANS – Performed poorly and will be stood down until completing a satisfactory trial.

### RACE 6 – WESTWOOD QUARRY TRAINERS INCENTIVE FINAL – 2150m MS

### RACE 7 – LADBROKES MEANDER VALLEY CUP – 2650m SS

MONTGOMERY BURNS – Galloped away. A post-race vet examination revealed hopple rub to the near hind. A 7-day stand-down period was imposed

IMPERIAL LAZ – Began badly and will be out of the draw in future standing start events

BEACH DANCER – Began badly and is on its last chance in the standing start draw. Hung in under pressure in the home straight

General – Stewards spoke to the starter prior to the all-clear to ascertain whether he had activated the tapes, or that the tapes had been broken by Fleetwood Rock who had made slight contact prior to release. The starter confirmed he had activated the start and all-clear was declared.

Stewards fined Tiarna Ford \$100.00 under AHR 163A(1) for crossing her reins nearing the winning post

### RACE 8 – DON PECK MEMORIAL – 2150m MS

LOLOYA LILLY – Gave ground and placed on its last chance to race competitively

CENTURIAN MISS – A pre-race vet examination was conducted, and the mare was passed fit to start.

EVERYTHING BUT THE – Severely checked racing into the back straight on the first occasion by Sportzsilk. Broke a connecting hopple strap in the incident and was retired from the event.

SPORTZSILK – Broke gait racing into the back straight on the first occasion. Placed on its last chance to race truly

### RACE 9 – PURINA SUPERCOAT PACE – 1670m MS

NOT YET MUM – A pre-race vet examination was conducted, and the gelding was passed fit to start

HAY MIKI – Raced rough under pressure in the home straight

### RACE 10 – CARRICK INN PACE – 2150m MS

CINCINNATI – Pulled hard throughout

GYPSY ARMOUR – Tended to hang outwards in the early to middle stages.
