Trainers with multiple runners in a race advised Stewards of intended tactics.

### RACE 1 – TREVOR AND MAJORIE LEIS PACE – 2180M MS

SHEEZA SOHO – Tightened racing out of the front straight on the first occasion and contacted several marker pegs

MY MATE LUKE – Hung inwards racing into the first turn. Gave ground in the final lap

CAPTAIN CHEDDAR – Pulled hard during the early and middle stages

General – Stewards inquired into the reasons for Sheeza Soho being tightened and contacting several marker pegs leaving the front straight on the first occasion. After viewing the patrol and acting on their own observations, Driver Luke Hooper (My Mate Luke) was reprimanded under AHR 168(1)(a) for careless driving, in that he attempted to cross down to the marker pegs in advance of Sheeza Soho when not clear to do so. Stewards took into consideration his good driving record in respect to that rule when assessing penalty.

## RACE 2 – THE STANLEY NUT CLAMBER PACE – 1892M SS

FIVEFORTY – Broke after the start and placed on its last chance in the draw. A post-race vet examination revealed no abnormalities

CINOCAL JAMANE – Broke after the start and will continue to be out of the draw in standing start events

RANIERI – Checked after the start when Cinocal Jamane broke

## RACE 3 – THE DUCK RIVER CUISE PACE – 2180M SS

JILLIBY JAY SEA – Pulled hard in the early to middle stages

ONEOFTHELADS – Fractious before the start, reared as the tapes released, and paced roughly for a few strides. Placed on its last chance in the draw

KIAVINO STRIDE – Fractious before the start and galloped out.

NIKITA JO – Held up for clear running in the home straight.

General – Stewards delayed the all-clear to allow Driver Mark Yole (Oneofthelads) to view the patrol footage as he believed his horse had not been afforded a fair start. After viewing the patrol footage, stewards were satisfied that Oneofthelads was always facing the tapes, that he had not been impeded by another runner, and that he reared up simultaneously to the tapes being released. As such he was afforded the opportunity of a fair start and all-clear was given on the judge's numbers.

## RACE 4 – TALL TIMBERS PACE – 2180M MS

HOWSWEETTHESOUND – Broke gait racing into the home straight on the first occasion. Last chance to race truly.

## RACE 5 – INAUGURAL CIRCULAR HEAD CUP – 2180M SS

TWILIGHT BEACH – Began badly and placed outside the draw in future standing start events

ANDAMAN BAY – Tightened and raced rough for a stride approaching the home turn when Repetitive shifted in.

INSIDE THREE BARS – Raced roughly for a stride leaving the front straight after receiving the bell. Gave ground over the concluding stages

General – Stewards spoke to Driver Hannah Van Dongen (Repetitive) regarding the incident where Andaman Bay was tightened and raced roughly approaching the home turn. Ms Van Dongen put forward that her horse did shift down the track marginally as he was beginning to tire. After viewing the patrol footage, it was accepted that the horse did shift inward slightly when put under pressure, however, stewards reminded her that she is obliged to stop driving and straighten the horse in similar circumstances. Consequently, Ms Van Dongen was issued with a reprimand under AHR 168(1)(a) for careless driving.

#### **RACE 6 – LADBROKES BIG BET PACE – 2180M SS**

DONE WELL – Began badly and placed on its last chance in the standing start draw. Driver Tiarna Ford reported that her tyre deflated during the run

PUNTARNO STRIDE – Pulled hard in the early and middle stages

WAVETHEBILL – Stood flat footed and began slowly. Placed on its last chance in the standing start draw. The horse over-raced after catching the field.

#### **RACE 7 – PERRY'S QUALITY EATS STAKES – 2180M MS**

TASSIE DAZZLER – Pulled hard in the early stages. Gave ground over the concluding stages

YURUGA LASS – Out of position at the start. Gave ground over the concluding stages and placed on its last chance to race competitively

UNMATCHED – Out of position at the start. Hung in at various stages in the final lap

General – Drivers Todd Rattray (Unmatched) and Hannah Van Dongen (Yuruga Lass) were fined the sum of \$50.00 under AHR 162(1)(h) for failing to come into position at the start
