Stewards spoke to trainer Joshua Wright (Chocolates Can) regarding the greyhounds galloping action nearing the winning post where he appeared to ease briefly. After taking evidence, watching the patrol footage and acting on their own observations, stewards were satisfied that Chocolates Can baulked at the reflection of the judge's mirror which shone across the track. Once the greyhound passed the reflection, he flattened out and chased keenly into the catching pen. Stewards were comfortable giving the dog the benefit of the doubt with regards to GAR 124 on this occasion given the circumstances and the dog's unblemished record.

Stewards spoke to trainer Jamie Brazendale (Reindeer Hedgehog) regarding the greyhound's actions nearing the winning post. After taking evidence and watching the patrol footage stewards were satisfied that the greyhound failed to pursue the lure. A subsequent vet examination found the dog to have suffered a right hind toe injury (3rd and 4th metatarsal). Under the provisions of GAR 125(1)(a) the greyhound was found to *have failed to pursue the lure by reason of injury* and a 7-day stand-down plus completion of a satisfactory trial was imposed

Stewards spoke to trainer Nicholas Howlett regarding the actions of Spare A Dime during the running of the race. After watching the patrol footage and acting on their own observations, stewards were satisfied that the greyhound made muzzle contact on two separate occasions – once on the home turn, and again halfway down the home straight. A post-race vet examination revealed a minor spike wound, and 3-day stand-down period was imposed. Stewards were comfortable that the injury had no bearing on the aforementioned incidents as until the dog made muzzle contact with Deadly Ernest on the first occasion, it had not contacted any other greyhound in the field. It is the opinion of the stewards that the injury occurred during the marring incident, not prior. As this was his 2nd offence under GAR 124 for marring, a 28-day stand-down from all tracks and satisfactory trial will be required before racing again.
