General: Trainers with multiple runners reported pre-race tactics

RACE 1 – THE BOTTLE-O HADSPEN PACE – 2200M MS

WAVETHEBILL – Gave ground and placed on its last chance to race competitively

MAGIC JOE – Inconvenienced when Wavethebill gave ground

LYNARD SKYNYRD - Inconvenienced when Wavethebill gave ground

ANOTHER NIEN – Hung in on the turn off the back straight final

General – Driver Jacob Duggan reprimanded under AHR 156(2)(b) for an incorrect whip action

RACE 2 – LADBROKES HOSTED POTS – 1680M MS

FANCY ANOTHER – Broke gait racing into the home straight on the first occasion.

HARLEY GLENWOOD – Contacted a marker peg entering the back straight first time. Checked and broke on the home turn when Winning Brew hung inwards.

VOODOO RANGER – Inconvenienced by Left One Hangin when that horse hung badly in the back straight final

WINNING BREW – Hung inwards on the home turn and a warning was placed on against the horse

QUAY – Tightened over the marker pegs by Left One Hangin when that horse hung badly in the back straight final. Inconvenienced by Harley Glenwood when that horse was tightened on the home turn.

LEFT ONE HANGIN – Hung inwards severely on a number of occasions. The horse is stood down until completing a satisfactory trial. A post-race vet examination revealed no abnormalities

HES FIRST CLASS – Checked when Fancy Another broke gait on the first turn

ONLY GLORY – Inconvenienced when Fancy Another broke gait on the first turn

RACE 3 – BE AT THE EASTER CUP 4 APRIL PACE – 1680M MS

PAZIAH – Shifted out on a couple of occasions in the early and middle stages. Shifted out again under pressure in the home straight and advantaged Debt Til We Part. After viewing the patrol footage, it was evident that driver Todd Rattray was attempting to keep his horse straight, consequently, a warning was placed against the horses' racing manners.

I AM CAESAR – Pulled hard in the middle stages

CAPTAIN CHEDDAR – Contacted the mobile barrier just before release and paced roughly after the start.

General – Driver Luke Hooper was fined \$200.00 under AHR 156(2)(b) for an incorrect whip action

RACE 4 – LADBROKES EASTER CUP HEAT 1 – 2698M SS

PARDOE PLUGGA – Began badly and placed on his last chance in the standing start draw.

DE GOEY – Galloped out

GLENLEDI ELVIS – Galloped out. Gave ground. A post-race vet examination revealed no abnormalities

MAGNETIC TERROR – Began badly and will continue to be drawn right outside the draw.

General - Driver Dylan Ford was fined \$100.00 under AHR 170(1)(a) for having his foot out of the sulky rest for longer than was necessary after the start

RACE 5 – VICTORY IMAGES PHOTOGRAPHY STKS – 2200M MS

KEEPER IDEAL – Pulled hard in the middle stages

MAJOR LESTER – Fractious in the score up. Raced roughly in the score up. Out of position at the start. Placed on its last chance in the draw.

RACE 6 – LADBROKES EASTER CUP HEAT 2 – 2698M SS

A false start was called at the first start when Rocks Roy swung sideways and got his hoof into the cart of Iron Clad simultaneous to the tapes being released

FLEETWOOD ROCK – Shifted out under pressure in the home straight and allowed a run to his inside for Iron Clad. Driver Gareth Rattray was reprimanded under AHR 162(1)(www)(iii) for allowing his horse to shift out advantaging another runner.

ROCKS ROY – Caused false start and placed on its last chance in the draw

ANYTHING GOES – Gave ground from the 400m. A post-race vet examination revealed no abnormalities

GORDONS BAY – Galloped out

MAEBEE - Shifted out under pressure in the home straight and allowed a run to his inside for The Shallows. Driver Connor Crook was reprimanded under AHR 162(1)(www)(iii) for allowing his horse to shift out advantaging another runner.

RACE 7 – LADBROKES BIG BETS COPY NOW PACE – 2200M MS

KOSTYUK LEIS – Shifted out under pressure in the home straight

ASHANTE QUEEN – Held for clear running in the home straight

ANGELSHAVTIME - Held for clear running in the home straight

JEREMY WELLS - Held for clear running in the home straight

RACE 8 – FIND US ON FACEBOOK AND INSTAGRAM STKS – 1680M MS

IRIS BROWN – Held up early in the straight

IDEN REGAL WAVE – Held up in the home straight

RACE 9 – FAMILY FUN SATURDAY 4 APRIL STKS – 1680M MS

LIKEABLE ROGUE – Gave ground from the 600m

SOKY'S LINE – Broke gait at the 800m. Stood down until the completion of two satisfactory trials
