RACE 1 – TASMANIAN HORSE TRANSPORT PACE – 2090M MS

DARE YOU TO MOVE – Pulled hard in the middle stages

RACE 2 – LADBROKES QUICK MULTI PACE – 2090M MS

THEE OLD BOMB – Gave ground. A post-race vet examination revealed the horse suffered atrial fibrillation. The horse is stood down for 14 days from racing and trialing. Must also undergo an ECG before trialing, and must satisfactorily trial before racing again.

WE SALUTE YOU – Inconvenienced when Thee Old Bomb gave ground

MY WAY – Hung out in the back straight and on the final turn

RACE 3 – DOWNSBYTHESEASIDE@WOODLANDS STUD PACE – 2090M MS

ZEUS IMMORTAL – Held up for clear running in the straight

RACE 4 – WOODLANDS STUD YOUR GENTIC EDGE PACE – 2090M MS

CMON SHARKEY – Inconvenienced when Areyawatchingthis gave ground.

POST LAZARUS – Broke gait leaving the back straight on the first occasion, placed on its last chance to race truly

RACE 5 – FEHLBURGS PRODUCE SPRINT LANE PACE – 2090M MS

FEELINKINDALUCKY – Pulled hard in the middle stages and gave ground from the 400m

LALIBELA – Inconvenienced at the 300m when Feelinkindalucky gave ground.

RACE 6 – SMITHAWARDS PACE – 1609M MS

SPOOKY GIRL – Query improved performance

General – Stewards questioned trainer Danny Malone regarding the apparent improved performance of Spooky Girl. Mr Malone put forward that he has changed a few things with the mares training workload, including swimming her more and keeping her away from the track. He also suggested that Spooky Girl received a good drive and a better trip today from a softer barrier draw. Mr Malone explained that he had expected a better effort today and that he had supported his mare. Stewards noted Mr Malones comments.
