A post-race vet examination of CRUISING GARY revealed no abnormalities.

Stewards inquired into action of CRUISING GARY on the final bend and in the home straight. After viewing the patrol footage, the greyhound was found to have failed to chase and was suspended under GAR 124 for a period of 28 days and until completing a satisfactory trial. At the inquiry trainer Mr. Wayne Howells used improper language and stewards issued a reprimand under GAR156(F)(ii) for misconduct. When assessing penalty stewards considered Mr. Howells good record and contrition for conducting himself in that manner.
