A post-race veterinary examination of VERY SNEAKY, who contacted the catching pen gate, revealed the greyhound to have a slight graze to the superficial lateral wrist, and was lame immediately post-race, however had returned sound upon reaching the kennels. VERY SNEAKY was subsequently stood down from racing for a period of 7 days.

A post-race veterinary examination of HIGHGATE WINSTON, which jumped the rail after escaping the catching pen, revealed the greyhound to have no abnormalities.

*General:*

*TAH JOE completed a Stewards Trial over 278M for marring with three other greyhounds. Weighing 30.9 Kg and beginning from box 5, this greyhound completed the trial in 16.77 seconds and subsequently did not qualify.*

*BROTHER'S KEPPER completed a satisfactory Stewards Trial over 515M for failing to pursue by reason of injury with two other greyhounds. Weighing 33.4 Kg and beginning from box 3, this greyhound completed the trial in 29.98 seconds and has been cleared to race at all tracks except Hobart (461m only).*
