POWER UP – Shifted out under pressure in the home straight.
WAVETHEBILL – Gave ground from the 600m and warning was placed against the horse for performing poorly.
GOODTIME OSCAR – Inconvenienced when WAVETHEBILL gave ground.

RACE 3 – DOWNBYTHESEASIDE @ WOODLANDS STUD PACE – 1609m MS

AWAY GAME – Contacted several marker pegs on the turn into the straight on the first occasion, and again on the turn into the home straight final. Driver Hannah Van Dongen was fined \$50.00 under AHR 163(1)(c)(ii).
STEPUPANDDANCE – Held up early in the straight.

RACE 4 – LADBROKES QUICK MULTI PACE – 2090m MS

GEE YOUNG – Broke gait leaving the front straight on the first occasion. Warning issued.
