### RACE 1 – LADBROKES QUICK MULTI – 1609M MS

NO RACING INCIDENTS

### RACE 2 – WOODLANDS STUD SHUTTLING GREAT SIRES PACE – 1609M MS

GEMMY LOU – Shifted out under pressure in the home straight

ZONED IN – Raced roughly on the home turn

IDEN ELIZA JANE – Out of position at the start. Driver Peter Jakowenko was reprimanded under AHR162(1)(h) for failing to come into position at the start.

MAJOR POPPI – Contacted a marker peg on the home turn

### RACE 3 – BOTRA NOVICE DRIVERS SERIES HT 1 – 1609M MS

MILLYCENT – Was inconvenienced at the 600m when the pace in the one-wide line momentarily decreased and she contacted the sulky wheel of A Lot Like Pendles

RESURGENT WARRIOR – Was inconvenienced at the 600m when the pace in the one-wide line decreased

A LOT OF PENDLES – Had its near side sulky wheel contacted at the 600m and had its tyre deflated.  
GOBSMACKED – Underwent a pre-race vet examination as it was backing up from Friday night

General – Stewards inquired into the reasons for A Lot of Pendles suffering a flat tyre at the 600m. After viewing the patrol footage, it was ascertained that the pace in the one-wide line decreased momentarily, for no apparent reason, which resulted in Resurgent Warrior contacting the sulky wheel. No blame could be attributed to any one driver, so no further action was taken.

#### **RACE 4 – WOODLANDS STUD YOUR GENETIC EDGE – 1609M MS**

WHISKEY CAVALIER – Pulled very hard in the score up, and during the early and middle stages of the race. Consequently, the horse began to contact its own sulky and pace roughly. When questioned, driver Jacob Duggan stated that he was concerned that the horse may either choke down, or break gait and cause interference, so he decided to retire the horse from the event. Stewards imposed the completion of a satisfactory trial on the horse. Stable representative Jordan Chibnall reported that she will speak to connections with a view to possibly retiring the horse.

#### **RACE 5 – BOTRA NOVICE DRIVERS SERIES HT 2 – 2090M MS**

GOODTIME OSCAR – Pulled hard during the early and middle stages of the race. Stewards spoke to driver Brodie Davis regarding his whip action and issued a reprimand under AHR156(2)(a) for an incorrect whip action

MISTA EAGLE – Stewards spoke with driver Grace Jones regarding her whip action and issued a reprimand under AHR156(2)(a) for an incorrect whip action

#### **RACE 6 – TYPEFACE PACE – 2090M MS**

QUALIFY – Hung in and contacted several marker pegs on the final bend

#### **RACE 7 – BOTRA NOVICE DRIVERS SERIES HT 3 – 2090M MS**

AWAY GAME – Contacted a marker peg on the final turn

STEPUPANDANCE – Pulled hard during the early and middle stages

LOUTENANT – Gave ground from the 600m. A warning was placed against the horse for its competitiveness

COOLANDCOLLECT – Gave ground over the concluding stages

#### **RACE 8 – BOTRA NOVICE DRIVERS SERIES HT 4 – 2090M MS**

SMILING MIA – Locked wheels with James Cagney at the 400m

JAMES CAGNEY – Shifted in under pressure at the 400m and locked wheels with Smiling Mia

ROCKS ROY - Underwent a pre-race vet examination as it was backing up from Friday night

WE SALUTE YOU – Pulled hard in the early stages.

OH NO NEVER AGAIN – Broke gait racing out of the front straight on the first occasion. A warning was placed against the horses’ racing manners.

**RACE 9 – FEHLBURGS PRODUCE SPRINT LANE PACE – 2090M MS**

SMOOTH REASON – Pulled hard throughout
