A post-race vet examination of She's Trouble revealed pain in both hamstrings. Notwithstanding, stewards spoke to trainer Hannah Pearce regarding the bitch's actions when bumping with Tony The Turtle in the home straight. After hearing the evidence and viewing the patrol footage, it was determined that Shes Trouble had eased half-way down the straight. Consequently, she was charged under GAR 125 for failing to pursue the lure by reason of injury, and imposed a 7-day stand-down period as well as a satisfactory trial.

A post-race vet examination of Wallet Moth revealed no abnormalities. Stewards questioned kennel representative Michael Sheriff regarding the greyhound's actions when bumping with Rojo Maximus running into the first turn. Mr Sherriff put forward that after being checked firstly by Tony The Turtle, and then Hey Jett, the greyhound had become unbalanced. He further stated that the bumping with Rojo Maximus was exacerbated by him trying to turn into the bend while not being able to get back onto his correct leg. After viewing the footage and hearing the evidence presented, stewards accepted that there was no muzzle contact and gave Wallet Moth the benefit of the doubt regarding failing to pursue the lure.
