*General: TRAINERS WITH MULTIPLE RUNNERS IN A RACE REPORTED PRE-RACE TACTICS*

### RACE 1 – TTC ON FACEBOOK PACE – 1609m MS

*The start was delayed approximately 2 minutes due to a photo finish issue.*

HAVEYOUETMAYNARD – Gear failure; bell boot became displaced in running.

INHISOWNRIGHT – Broke gait on the home turn and a warning was issued.

SOME HIGH – Raced erratically during the score up.

### RACE 2 – LADBROKES POPULAR SRM PACE – 1609m MS

DOLCE DRAMA – Broke in the score up and warning was placed against the geldings' starting manners.

EYE SEE ARMOUR – Broke after the start and will be placed out of the mobile barrier draw. Broke gait in the home straight and a warning was issued.

JEREMY WELLS – Was inconvenienced in the score up when DOLCE DRAMA broke gait. Pulled hard in the early and middle stages.

MODERN JIVE – Broke in the score up and was out of position at the start. Will be placed out of the mobile barrier draw.

### RACE 3 – SMITHAWARDS PACE – 1609m MS

INVITATION ONLY – Shifted inwards under pressure in the home straight and had it sulky contacted by EAGLE WATCH.

EAGLE WATCH – Pulled hard in the middle stages. Inconvenienced by INVITATION ONLY from the 300m until the home turn when that horse began to tire. Hung outwards for a stride in the home straight when attempting a run to the inside of INVITATION ONLY, who had shifted in marginally under pressure. Consequently, EAGLE WATCH was tightened and contacted the sulky of INVITATION ONLY. Stewards were satisfied that no driver was at fault and no further action was taken.

### RACE 4 – WOODLANDS STUD YOUR GENETIC EDGE PACE – 2579m SS

STEPUPANDDANCE – Broke after the start and will be placed out of the draw in future standing start events.

ONEHANDONEBOUNCE – Raced rough after the start.

IAMAHUNTER – Galloped out and will be placed out of the draw in future standing start events.

ROCKS ROY – Inconvenienced after the start by STEPUPANDDANCE breaking gait.

JILLIBY JAY SEA – Raced roughly after the start.

WILL HE PIKE – Was slow to begin.

### RACE 5 – WOODLANDS STUD SHUTTLING THE WORLDS GREATEST SIRES PACE – 1609m MS

SOHO PINA COLADA – Raced erratically and hung outwards in the home straight. Locked wheels with MY ULTIMATE WOODY briefly at the 100m.

HAMMERING SEAS – Shifted out under pressure in the home straight.

ZONED IN – Driver Jack Watson was fined \$100.00 under AHRR 156(4)(b)(v) for using the reins and whip passed the winning post.

**MY ULTIMATE WOODY – Locked wheels with SOHO PINA COLADA at the 100m.**

ASTORMZABREWEN – Hung inwards under pressure in the back straight final.

IYLAC CHAMBER – Pre-race vet examination due to not having started since Nov '25 and was passed fit to start.

*General – The first half of the last mile was run in 65.4 which is fractionally outside of the time standard of 65.0. Stewards took no action due to the prevailing weather and track conditions.*

### RACE 6 – TTC LIFE MEMBERS PACE – 2090m MS

COLBY SANZ – Contacted a marker peg entering the back straight final.

MAJOR LESTER – Gave ground from the 700m and was retired from the event. A post-race vets examination revealed that the horse had suffered from atrial fibrillation. Subsequently stood down for 14 days and until the successful completion of an ECG and satisfactory trial.

IMPERIAL LAZ - Driver Jack Watson was fined \$100.00 under AHRR 156(4)(b)(v) for using the reins and whip passed the winning post. In assessing penalty stewards took into account that they had yet to address the previous instance from Race 5 with Mr Watson. Driving master Neville Webberley was present during the inquiry and was asked to work with Mr Watson to prevent a further occurrence.

*General – The first half of the last mile was run in 65.9 which is fractionally outside of the time standard*

**RACE 7 – LADBROKES QUICK MULTI PACE – 2579m MS**

**RACE 8 – FEHLBERGS PRODUCE SPRINT LANE PACE – 2090m MS**

SOHO TUXEDO – Was tightened in the home straight when racing in restricted room between REPETITIVE and ASHANTE QUEEN, who both had a tendency to shift ground under pressure.

REPETITIVE – Shifted ground under pressure just after entering the home straight.

ASHANTE QUEEN – Shifted out under pressure in the home straight. Driver Grace Jones was fined \$100.00 under AHRR 162(1)(www)(iii) for allowing her horse to shift ground advantaging another runner SOHO TUXEDO.

ANDAMAN BAY – Held up for clear running in the home straight.

**RACE 9 – TYPEFACE PACE – 2090m MS**

HALLIS BOY – Gave ground and a warning was issued.

RESURGENT WARRIOR – Driver Rodney Ashwood was fined \$100.00 under AHRR 156(4)(b)(v) for using the whip after the winning post.

MILLYCENT – Queried performance. When questioned, driver Mark Yole was at a loss to explain the poor performance tonight. He put forward that she may have struggled to handle the shifting surface as she was under pressure from the 700m and struggling to hold the back of SMILING MIA. Despite trying to save ground thereafter, she failed to run on at all over the concluding stages as expected. A post-race vet examination revealed evidence of wind sucking, which the trainer Paul Hill had not seen any evidence of previously. The trainer will investigate undertaking the Caslick procedure on the advice of the on-track vet.

PEANUT SUTTER – A post-race vet examination revealed minor abrasions to the near-side hind fetlock.
