A post-race vet examination of FRED DANGER revealed no abnormalities. Stewards spoke to trainer Hannah Pearce regarding the greyhound's actions over the concluding stages. After taking evidence and acting on their own observations, stewards found FRED DANGER guilty of failing to pursue the lure and imposed a 28-day stand-down period as well as the completion of satisfactory stewards trial.
