RACE 1 – SMITHAWARDS PACE – 2090m MS

SAPPHIRE GAMBLER – Was given permission to race without shoes. Trainer Wayne Yole reported to the Stewards that stable staff noticed the horse had lost a hind shoe when he was put on the float. Then on arriving at the track, it was noticed that the horse had also dislodged one of his front shoes.

RACE 2 – TYPEFACE PACE – 2090m MS

CUZZY JUNIOR – Inconvenienced at the 500m when BUSLOAD OF FAITH commenced to give ground.

SMILING MIA – Inconvenienced at the 500m when IDEN OLIVER restrained to obtain cover. Trainer Ray Pullen reported that is the intention of connections to retire the mare.

IDEN OLIVER – Was tightened at the 600m when DONNY IN PARIS crossed to the one wide line.

BUSLOAD OF FAITH – Pulled hard in the early and middle stages. Contacted his own sulky. Gave ground from the 500m. A warning was placed against the horse's competitiveness.

CAN FEEL THE FURY – Inconvenienced at the 500m when BUSLOAD OF FAITH commenced to give ground.

DONNY IN PARIS – Driver Paul Williams was fined \$200.00 under AHRR 156(2)(a) for an incorrect whip action. He was also reprimanded under AHRR 163(1)(a)(i) for causing crossing at the 600m when shifting from a three-wide position to a one-wide position.

SPOOKY GIRL – Raced roughly in the home straight on the final occasion.

RACE 3 – LADBROKES POPULAR SRM PACE – 1609m MS

MIRA DONNA – Query improved performance. Stewards spoke to stable representative Jacob Duggan who explained that they have only had the filly for a short time but that she had shown good ability at home and in a recent trial win. He further explained that she had drawn the backline at her most recent three starts, so she wasn't able to be driven as positively as she was tonight. With improved fitness Mr. Duggan said that they have been able to increase her workload and coupled with a significantly better barrier draw tonight we saw a much better horse. Mr. Duggan said that from similar draws in the future she will be driven in the same positive manner. Stewards noted Mr. Duggan's comments.

AREYAWATCHINGTHIS – Gave ground from the 700m. A post-race vet examination revealed the mare suffered atrial fibrillation. Consequently, stood down for 14 days and until the successful completion of an ECG and satisfactory trial.

LADY IN LINE – Gave ground from the 500m. A post-race vet examination revealed the mare suffered atrial fibrillation. Consequently, stood down for 14 days and until the successful completion of an ECG and satisfactory trial.

NOBLEZZ ADVICE – Was inconvenienced leaving the front straight on the final occasion when PARK LANE broke gait.

PARK LANE – Hung out and broke gait leaving the front straight on the final occasion. A warning was placed against the horse's racing manners.

JEREMY WELLS – Inconvenienced when PARK LANE broke gait leaving the front straight on the final occasion.

RACE 4 – TTC LIFE MEMBERS PACE – 1609m MS

MISS COLLAN – Underwent a pre-race vet examination having not started for 6 months and was passed fit.

WE SALUTE YOU – Lost a shoe in the warmup. Consequently, the on-course farrier removed the remaining hind plate and the horse raced bare behind.

RACE 5 – WOODLANDS STUD SHUTTLING THE WORLD'S GREATEST SIRES PACE – 2090m MS

BARBARY TALES - Underwent a pre-race vet examination having not started for 6 months and was passed fit.

RACE 6 – WOODLANDS STUD YOUR GENETIC EDGE PACE – 2090m MS

COUNT YOUR BLESSIN - Underwent a pre-race vet examination having not started for 6 months and was passed fit.

RACE 7 – FEHLBERGS PRODUCE BRIGHTON CUP – 2090m MS

THE SHALLOWS – Contacted his own sulky.

RACE 8 – LADBROKES QUICK MULTI PACE – 2090m MS

MY ULTIMATE WOODY – A post-race vet examination revealed no abnormalities. Stable representative Dylan Ford advised that the horse will be retired.

MAJOR POPPI – Commenced giving ground from the 700m. A post-race vet examination revealed no abnormalities. Poor performance stood down until completing a satisfactory trial. Stable representative Dylan Ford advised that the horse will be retired.

LETHAL REPLICIA - Underwent a pre-race vet examination having not started for 6 months and was passed fit.
