General – Stewards inquired into the reasons for ART HUNTSMAN being checked nearing the winning post. After taking evidence from Drivers Ethan Arnett (POST KEG) and Kayleb Williams (ART HUNTSMAN) and after viewing the patrol footage, it was determined that Mr. Arnett allowed his horse to shift inwards nearing the winning post when not clear of ART HUNTSMAN, resulting in that horse being checked. Mr. Arnett pled guilty to a charge of causing interference under AHRR 163(1)(a)(iii) and was suspended for one (1) race meeting. In assessing penalty stewards considered Mr. Arnotts guilty plea and good driving record. Mr. Arnett elected to take a nine (9) day stay of proceedings, and his suspension will commence 6 June 2026.
