BAD BOY BARNEY was declared a late scratching at kenneling by order of the vet. The greyhound was found to be lame in the right foreleg between the carpus and elbow. A 7-day stand-down was imposed.

Stewards questioned kennel representative Tonie Czerkiewicz regarding the improved performance of PACK LEADER today. Ms. Czerkiewicz stated that the dog had been quite injury prone since he made his racetrack debut. He was given approximately 8 weeks off after his 7th at Launceston on 16 March 2026, and since returning from that break has been free of the previous injury concerns. Consequently, the dog has slowly started to gain better race fitness and has grown in confidence. Stewards noted the comments and took no further action.
