General: Stewards questioned D. Ford (HORATIUS SPECULO) on the reasons he trailed a wheel from near the 800 metres to the 500 metres. D. Ford stated he initially moved wider on the track in an attempt to get E. Arnott on VANQUISH STRIDE to move wider in advance of him thereby affording him a trail, however when E. Arnott stayed in the running line, D. Ford returned to a true trailing position soon after. He added in the back straight he was trailing VANQUISH STRIDE who had a tendency to run up the track, and as he was following

that runner, HORATIUS SPECULO also moved up the track slightly. He stated he attempted to correct his line, however it proved difficult which resulted in HORATIUS SPECULO racing wider than a true marker peg position. In the circumstances stewards accepted the explanation provided by D. Ford, however reminded D. Ford of his obligation to have his horse trail the helmet of the driver he is following. It was noted that GO THE RED was inconvenienced when attempting to make its run from behind HORATIUS SPECULO.

General: Stewards questioned P. Jakowenko as to the reason he raced tight to the outside of WHERE'S THE SAVS near the 1800 metres. P. Jakowenko advised he was trailing B. Miller on VOODOO RANGER who was racing without cover; therefore, he believed he was in the running line which resulted in him racing tight on WHERE'S THE SAVS, who had BLISS AUTHORITY to its inside. As a result, WHERE'S THE SAVS was tightened, checked and broke gait and NEWYORK ROCKSTAR which was trailing was checked. In determining the matter stewards accepted that P. Jakowenko had a mistaken belief that he was in the running line due to the horse he was trailing, VOODOO RANGER racing wider than necessary and noted the circumstances. P. Jakowenko was advised that in future he should have greater awareness of where he is positioned on the track.
